Department of Correction's County of Origin Notification Form

Laura Cole reported on the DOC releases. John Sisson - doing well, working, no violations; Geri Perkins - living with parents, in outpatient treatment and doing well, no violations; Shawn Johnson - living in a Gessemane Ministries home, doing very well.

Juvenile Detention Alternative Initiative (JDAI) - Sonja Miles

Sonja Miles reported on the Juvenile Detention Alternative Initiative that Mason County implemented in 2009. The goals include reducing secure detention and increasing use of alternatives to detention. The average daily population has decreased in detention. The evidence shows the initiative is working and reduces cost to the taxpayers. They are now focusing on community outreach.

Discussion of how the various evidence based programs work.

Agency/Department Updates

DOC - Laura Cole - reported on how Bill 6204 has drastically changed how community corrections works. The program is called Swift and Certain. Staffing has increased in their office.

WCC - Steve DeMars- state agencies are still taking budget cuts. Talked about a new program to impact gangs and reduce assaults. Talked about conducting a tour of the prison for the CJWT.

Discussed moving the November meeting to November 14 at 7:30 a.m. to accommodate the holiday.

City of Shelton Police - Chief Eklund - have new officer going through training.

City of Shelton - Mayor Cronce - 6th Street Park near Civic Center has a problem with youth causing damage and the recommendation from the park advisory group was to close the park, rebuild it and then reopen. He has concerns because there is no plan to address how to prevent this from happening again.

Public Defense - Susan Sergojan - dealing with cases due to court ruling.

Mason County - Cmmr. Bloomfield - budget is the problem everywhere, election coming up.

Superior Court - Judge Finlay - they have a work group meeting to deal with criminal calendar scheduling.

Municipal Court - Shelby Conklin - video arraignment equipment has been up and working since October 1 and working well. She invited the group to visit.
