### Jail Population Report

Chief Haugen gave the population reports. Currently Mason County is housing the following:

Males: 90 Females: 19

He added that they are 5 inmates over their goal. He stated inmates needed to be removed from one area in order to add the Direct Supervision Unit (DSU). The DSU will add 40 beds.

Judge Finley stated they are continuing to work with video monitoring. They are working with the Facilities Department to get ready for the third judge.

Judge Steele said they currently have part time staff to assist with getting caught up.

Les Watson stated that the Shelton Police Department will be selecting a new Chief and will have interviews on the 27th.
