 - i. <u>TST Policies and Procedures-Update</u>- Reviewed updates and changes to the By-Laws.

Peggy Vanbuskirk motioned to move the revised Policies & Procedures to the County Commission for review. Eric Onisko seconded. Motion carried unanimously.

- ii. Current TST contract review- Abe reviewed 2021-2022 budgets for TST contracts
 - Recommend funding a two-year contract for NWRII with an increase of \$10,000/year
 - Recommend funding Olympic Health and Recovery Services (OHARS)
 - Recommended not funding Consejo for this next cycle and revisiting their needs for the next cycle.

Peggy Vanbuskirk motioned to move forward contract proposals to the Board of County Commissioners, Randy seconded. Motion carried unanimously.

- **c.** Homelessness and Housing: Todd Parker
 - i. <u>Coordinated Entry (CE)-Information</u>- Todd reviewed that WA State is currently updating the CE guidelines. Todd presented a report with graphs on Mason County's CE program data for the past few years and YTD. Sent the report on the CE Survey and reviewed results. Agency Communication, marketing plans and policies and procedures adherence have continued work to do.
 - ii. <u>Homeless Encampment Call-update</u>-Jeff Niten shared calling the encampment a "supportive encampment".
 - iii. <u>Contracting update-</u>Agencies have been sent information to update for upcoming contract renewals. Todd shared spreadsheet on 2021-2023 Housing Award breakdown. Awaiting on Commerce to get their awards announced. On target to get contracts out by July 1, 2021.
