3. PUBLIC COMMENTS:

Tom Davis was asking for support of the tiny home project at the February 5, 2019, City of Shelton meeting. There have been concerns voiced on what this will bring to the neighborhood, there is fear that it will affect the crime rate. There is hope to have a lease agreement signed by the middle of February.

4. COMMISSIONER REPORTS/COMMENTS:

Kathy had a meeting with Frank Pinter, the professional service contract between the housing authority and the county is done, and the housing authority is a special purpose junior taxing district. We can now make deposits and write checks. Kathy Haigh and Gary Gordon will the signers on the account.

There is a bid for \$119,000 to replace all the roofs at Pine Garden, it would add 25% more to do metal roofing. There was \$5000 given to them to start the roof that still has the blue tarp. That bid was \$10,000.

4-J Construction received a \$33,000 down payment so they can start the decks at Fairmont Coves. Kathy will be checking cost of hotels for temporary housing during construction.

Kathy has had a discussion with Cascade Management concerning Pine Gardens rent increase and the need to Cascade Management to payback the \$13,500 the borrowed in March 2018. This will make the final payment on the roof at Pine Garden.

Kathy donated \$200 to help with garbage clean up. This has become a serious issue at all the complexes. Gary Yando will contact Mason County Garbage to see if there is anyway that they can help with this problem. The major problem is the bigger more expensive items.

Kathy testified to the House of Representative Housing Committee in support of HB1406. There were 21 people that testified in support of this bill. This bill could bring a significant amount of money for housing into this County.

The budgets will all be ready for approval at the March meeting.

Gary Gordon made a motion authorizing the funding for Cogent Construction to do the roof at Pine Garden. The motion was seconded my Gary Yando. **Motion Passed**
