The board would like to recommend a Maintenance 1 position again for 2025 and will prepare to present to the Commission in July 2024.

Foothills Dog Park: Bill Long presented a pet friendly water fountain for the dog park. Bud will review the system and potential health risks. To be discussed at future meeting. Also requesting gate to be open/closed by gate keeper year-round.

Sandhill Play Toy: Will begin playground installation approximately March 2024.

Noxious Weeds: Kela wanted the Board to know that she would organize a work party for Truman Glick Park in April, preferably on Earth Day. Kela has since left the County. Once her replacement starts, we will touch base to formulate a plan to remove the ivy.

Park Tour: Diane suggested that another park tour be scheduled in Spring especially for the new Park Board members. Cassidy will develop a schedule and arrange transportation if necessary.

RCO Grant: Did not rate proposal high enough. Award has been denied.

Maintenance Report: Staff are currently working on replacing the Truman Glick fence, and routine maintenance of parks to prepare for ball season and clean up debris from windstorms.

Parks Budget: Parks Capital Improvement Budget allows up to 1 million in which the Sandhill playground equipment will be coming out of. Final Parks budget landed approximately \$46,000 higher for 2024 than 2023.

Comp Plan: To be reviewed at our next meeting. Information for comp plan and budget to be provided by Cassidy.
