 future date.
- Proposed RCO contract for the MCRA infield project, which would improve the MCRA infields
 on fields #6 and #7. Discussion ensued on whether the County's funds would be best suited for
 MCRA or Sandhill. No decisions were made.
- PUD Easement- John presented a request form PUD #3 for an easement to connect power to a
 pole behind the prosecutor's office to a garage on an adjoining neighbor's property. The
 Commission approved bringing the easement forward to a meeting for approval.
