- 1. Call to Order The Chairperson called the regular meeting to order at 9:03 a.m.
- 2. Pledge of Allegiance Vicki Kirkpatrick led the flag salute.
- 3. Roll Call Present: Commissioner District 1 Lynda Ring Erickson; Commissioner District 2 Tim Sheldon; Commissioner District 3 Ross Gallagher.
- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The Washington State Liquor Control Board sent notice of a special occasion liquor license application for North Mason Rotary, notice that Lakeside Bistro & Lounge has discontinued sales and service of liquor and notice of a new liquor license application for Krohn Family Farms.
 - 4.1.2 The Washington State County Road Administration Board is seeking County Engineer of the Year nominations.
 - 4.1.3 The Washington State Department of Ecology sent notice that Robert Gantenbein's term on the Mason County Water Conservancy Board will expire on April 21, 2010.
 - 4.1.4 The Washington State Department of Health is reclassifying a portion of North Bay commercial shellfish growing area from Conditionally Approved to Approved.

 - 4.2 Robert Thuring, County Engineer, announced that the contract for 2010 Manufacturing and Stockpiling of chip seal aggregate has been awarded to the low bidder, Miles Sand & Gravel Company of Auburn, WA at the price of \$223,658.47.
 - 4.3 Vicki Kirkpatrick, Public Health Director, read a proclamation declaring April 5-11th, 2010 as National Public Health Week in Mason County.
- 5. Open Forum for Citizen Input There was no citizen input.
- 6. Adoption of Agenda Cmmr. Ring Erickson/Sheldon moved and seconded to adopt the agenda as published. Motion carried unanimously. RE-aye; S-aye; G-aye.
- 7. Approval of Minutes Briefing minutes for March 15, March 22 and March 29, 2010 and regular meeting minutes for March 16, 2010.

Cmmr. Ring Erickson noted that she attended some of the briefings via telephone.

Cmmr. Sheldon/Rick Erickson moved and seconded to approve the briefing minutes for March 15, March 22 and March 29, 2010 and regular meeting minutes for March 16, 2010. Motion carried unanimously. RE-aye; S-aye; G-aye.

- 8.13 Approval to adopt the Flood Mitigation Assistance Addendum to the Natural Hazards Mitigation Plan. This addendum is necessary to provide the County access to an additional federal program that provides funding for flood mitigation projects under the Flood Mitigation Assistance (FMA) program and to address short comings in the base document.
- 8.14 Approval to authorize the Emergency Management Manager, Martin Best, to advertise, interview, and hire for the Emergency Management Coordinator position that is currently vacant.

This committee will assist staff in implementing the Department of Ecology stormwater grant, assist in crafting financial options to fund stormwater improvement activities and develop methods to involve more of

the public in efforts to protect water quality. They will serve until the conclusion of the stormwater grant which is anticipated to be June 2011, and may be continued at the discretion of the Commissioners.

8.26 Approval to sign the letter voicing objections to the new Washington State Liquor Control Board application for Krohn Family Farms for a domestic winery. This would require a change of use permit for the structure from the Mason County Department of Community Development, which has not been done.

8.27 Approval of the Memorandum of Agreement between Mason County and IAM&AW Local Lodge W38 for the Corrections and Support Staff Bargaining Unit.

Brenda Hirschi asked that items 8.7, 8.16, 8.20, 8.24 and 8.27 be removed for further discussion.

Cmmr. Ring Erickson noted that in item 8.1, DCD stands for Department of Community Development.

An audience member asked that items 8.7, 8.8, 8.10 and 8.14 be removed for further discussion.

Cmmr. Ring Erickson asked for a separate vote on item 8.2.

Cmmr. Sheldon commented that Amber Cervantes and her staff did a terrific job on item 8.9. It is tedious work and they spent a lot of time on it.

Sandy Tarzwell asked that item 8.26 be removed for further discussion.

Item 8.2

Cmmr. Ring Erickson stated that she would like more time to be briefed on the issues in the correspondence received today from KMAS regarding this item.

Cmmr. Ring Erickson/Sheldon moved and seconded to table item 8.2 for one week. Motion carried unanimously. RE-aye; S-aye; G-aye.

Item 8.7

Ms. Hirschi asked what the new title would be for the position.

Cmmr. Gallagher responded that it is being changed from HR/Budget to just HR.

An audience member asked for clarification on the change.

Cmmr. Gallagher explained that the Board advertised for an HR/Budget person and they were unsuccessful in finding a candidate so they are reverting back to just an HR position.

Ms. Hirschi asked what would happen with the budget work in the old job description.

Cmmr. Gallagher stated that the Board would probably contract out for the budget work. It will depend on what range the HR person is hired at.

Item 8.8

The audience member asked for a summary of the policy being adopted in the resolution.

Lisa Frazier explained that the Board was briefed on the draft resolution and policy. The draft resolution was approved by the Finance Committee. The document is avilable for public review.

Cmmr. Sheldon asked Ms. Frazier to explain who sits on the Finance Committee.

Ms. Frazier stated that the Finance Committee is the Treasurer, the Auditor and the Chair of the Board of Commissioners.

Item 8.10

The audience member asked if this amount was included in the 2010 budget.

Tom Moore explained that the item is part of the Belfair Sewer project. It is a bit of a change and will come out of the contingency fund, which is budgeted. About 10% of the project budget was put in contingency.

Ms. Hirschi asked how much is currently in the contingency fund.

Mr. Moore replied that it is a fluid number. There is about \$800,000 to \$900,000. There are also some pending items in negotiations.

Cmmr. Sheldon added that this is essentially a change order. Working with gas lines is dangerous and it makes sense for Cascade Natural Gas to do it.

Item 8.14

The audience member asked if this amount is budgeted.

Marty Best replied that it is budgeted. It is the result of an unanticipated early retirement.

Item 8.16

Ms. Hirschi asked how much is budgeted for the item.

Mr. Thuring responded that there is no budgeted item for this. It is on an 'as required' basis for specific project work. If funds were required they would come out of the particular project budget.

Item 8.20

Ms. Hirschi asked how much the hardware portion of the system would cost.

Dave Loser replied that the hardware would be approximately \$10,000 in total, in addition to the \$85,000 for the software.

Cmmr. Gallagher asked how this software would interface with the County's other systems.

Mr. Loser explained that 22 other counties in the state use this software. It interfaces with most of the financial systems and should work with the County's current system.

Item 8.24

Ms. Hirschi noted that there are 4 or 5 members of this task force that do not live in Mason County.

Cmmr. Gallagher stated that is correct.

Ms. Hirschi asked if those members would be developing financial policy for citizens in the county.

Cmmr. Sheldon clarified that some of the people on the list do not live in Mason County, but they represent a group. For example, Matt Matayoshi is employed by the Economic Development Council and represents their 70 or 80 members. He doesn't have a problem with these people not living in the county because they represent a group of individuals or business in Mason County.

Cmmr. Ring Erickson noted that advisory groups only make recommendations to the Commission. The Commission is the deciding body.

Ms. Hirschi suggested that those who do not live in Mason County should be non-voting, ex-offico members of the group.

Cmmr. Sheldon did not agree. Designating some members as ex-officio would leave them to believe that they are not full participants. Mr. Matayoshi represents active businesses in Mason County. He should be able to participate fully to represent his group. The Squaxin Island Tribe's representative may not live in Mason County, but the Tribe should not be an ex-officio member either.

Ms. Hirschi wanted it noted that she takes exception to this.

Item 8.26

Ms. Tarzwell asked if the item could just be tabled to allow time for the permit change to be completed instead of objecting to the application.

Mark Core explained that the facility is currently approved as a garage/storage building. In order for it to become a winery with a tasting room the owners need to apply for a change of use. The structure hasn't even been finally approved as a garage/storage unit yet. Technically, they don't even have occupancy.

Ms. Tarzwell added that she also had questions about a couple of the other Consent agenda items as well.

Item 8.27

Ms. Hirschi asked if this item would have an impact on the 2010 budget.

Monty Cobb replied that there isn't a specific amount anticipated yet. There is a salary survey to be conducted. A rough estimate would be \$15,000 if there were a 1% increase over the entire corrections unit. If the increase were 10% it would be \$150,000. There are differences in the preliminary numbers between the different positions.

Item 8.11

Ms. Tarzwell asked when the lighting project was approved and if it is installed through the PUD.

Mr. Thuring explained that this was funded out of the stimulus package. A contract was advertised last July. 15 solar streetlights were to be installed at 12 locations. 2 units were to be installed at the Sandhill/Hwy. 300 intersection, but they were unable to find a satisfactory foundation for the poles in the area. Those 2 units were relocated to 2 individual intersections. This item is the administrative aspect to allow the costs to be charged to the road on which the units are being installed.

Item 8.12

Ms. Tarzwell asked what a private line occupancy permit is.

Mr. Thuring explained that in this case it is a sewer line and water line that will be run through the right-of-way. It is basically a franchise agreement between the owner/operator of the facility and the County to allow the installation of the lines. It is a standard item.

Item 8.19

Ms. Tarzwell asked for an explanation of the service and what it might cost.

Mr. Loser responded that the County had been using private contractors to outfit patrol cars and other equipment with radio service. Thurston County has set up their own radio shop and they will just charge their regular rate to use the shop.

Cmmr. Gallagher asked if the service is provided on site.

Mr. Loser replied that it depends. It is typically more expensive to do the service at Mason County's shop.

<u>Item 8.5</u>

Cmmr. Sheldon stated that he has now had time to read the contract and he feels comfortable approving it. If the wording of the item were changed it could be approved today.

Ms. Hirschi asked what the deliverables of the contract are.

Cmmr. Sheldon explained that the company is contracted to interface with the public to address their concerns. They will have a hotline to answer questions and they will handle a lot of the questions regarding hooking up to the sewer. He doesn't want to delay these services any longer.

Mr. Moore added that there are a number of properties in the initial service area that do not have direct road frontage. This company will work with those people to place side sewers.

Ms. Hirschi stated that her issue is that citizens have not been given a clear budget on this project for 2010.

Cmmr. Ring Erickson/Sheldon moved and seconded to approve Consent items 8.1 through 8.27, with the exception of item 8.2, and an amendment to item 8.5 to read: *Approve* to continue to April 13, 2010 the resolution authorizing the Chair to sign a contract, not to exceed \$220,978.50, with EnviroIssues of Seattle, Washington to continue providing professional assistance informing the public of on-going construction progress and activities to convert on-site septic systems to the Belfair Wastewater Reclamation System. This item was tabled from March 16, 2010 and staff is requesting it be tabled to April 13th. Motion carried unanimously. RE-aye; S-aye; G-aye.

RESOLUTION NO. 16-10 AMENDING RESOLUTION 117-09 TO IMPLEMENT A REVISED NON-UNION SALARY RANGE ALIGNMENT

WHEREAS, RCW 36.40.080 states that "...the Board of County Commissioners shall fix and determine each item of he budget separately and shall by resolution adopt the budget...",

WHEREAS, RCW 36.16.070 states that "...the Board shall fix the compensation of all employees...",

WHEREAS, the Board has approved a job title change from Director of Human Resources/Budget & Finance to Human Resources Director at range 35, but may go up to Range 39 depending upon qualifications.

Mason County Interfund Loan Policy and Procedures February 2010

Pursuant Volume 1, Part 3, Chapter 4, Page 1 of the Washington State Budget Accounting and Reporting System (BARS) and the Mason County Debt Policy the Mason County Finance Committee recommends the following as policy and procedures for approval of interfund loans.

The BARS Manual does not attempt to determine which moneys of a municipality may or may not be available for interfund lending, since the special character of some moneys involves commitments and restrictions which would require individual consideration. Generally however, is permissible to make interfund loans of those municipal moneys which are clearly inactive or in excess of anticipated cash needs throughout the duration of the loan and legally available for investment.

The appropriate elected official and/or department head in charge of such funds shall be consulted for determination of the availability of the funds for an interfund loan.

Pursuant to the adopted County Debt Policy all interfund loan resolutions and repayment schedules will be reviewed by the County Treasurer to ensure that the appropriate reimbursable language is included, the correct fund numbers are used, and to develop the appropriate debt repayment schedule.

The minimum acceptable procedures for making and accounting for interfund loans are as follows:

- 1. The legislative body of a municipality must, by ordinance or resolution, approve all interfund loans, indicating the lending fund, and provide in the authorization a planned schedule of repayment of the loan principal as well as setting a reasonable rate of interest (based on the external rate available to the municipality) to be paid to the lending fund.
- 2. Interest should be charged in all cases, unless:
- a. The borrowing fund has no other source of revenue other than the lending fund; or
- b. The borrowing fund is normally funded by the lending fund.
- 3.. The presumptive minimum interest rate acceptable will be the current Local Government Investment Pool (LGIP) or "State Pool" rate plus 2%, however the Board may set a different interest rate based on the specific circumstances and conditions pertaining to the loan. The Treasurer's Office should be contacted to establish the current "State Pool" rate at the time the inter-fund loan is initiated. Other considerations for an acceptable interest rate that may apply must be submitted in writing and approved by the Mason County Finance Committee prior to initiation and approval of the Interfund Loan by the Board.

- 4. The borrowing fund must anticipate sufficient revenues to be in a position over the period of the loan to make the specified principal and interest payments as required in the authorizing ordinance or resolution.
- 5. The term of the loan may continue over a period of more than one year, but must be "temporary" in the sense that no permanent diversion of the lending fund results from the failure to repay by the borrowing fund. A loan that continues longer than three years will be scrutinized for a permanent diversion of moneys. (Note: these restrictions and limitations do not apply to those funds which are legally permitted to support one another through appropriations, transfers, advances, etc.)
- 6. Appropriate accounting records should be maintained by each department to reflect the balances of loans in every fund affected by such transactions and documentation provided in a timely manner to the Mason County Treasurer and Mason County Auditor's Finance Department to facilitate auditing and annual reporting requirements.

BE IT FURTHER RESOLVED, that the Property Manager is directed to issue public notice regarding the proposed declaration of surplus and sale of real property for three consecutive weeks in a newspaper of general circulation within Mason County.
