BOARD OF MASON COUNTY COMMISSIONERS' PROCEEDINGS

April 12, 2011

- 1. Call to Order The Chairperson called the regular meeting to order at 9:02 a.m.
- 2. Pledge of Allegiance Bill Dewey led the flag salute.
- 3. Roll Call Present: Commissioner District 1 Lynda Ring Erickson; Commissioner District 2 Tim Sheldon; Commissioner District 3 Jerry Lingle.
- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The Washington State Department of Health sent an initial order reclassifying a portion of Pickering Passage commercial shellfish growing area from conditionally approved to approved.
 - 4.1.2 The US Census Bureau announced that the 2010 Census Count Question Resolution Program will take place between June 1, 2011 and June 1, 2013.
 - 4.1.3 The Washington State Redistricting Commission provided 2010 Census redistricting data.
 - 4.1.4 The League of Women Voters of Mason County sent an invitation to a presentation by the State Auditor regarding open government.
 - 4.1.5 Rick and Cherie Blake expressed concerns regarding a proposed race track on Eels Hill Road.
 - 4.1.6 Duane Wilson, Cassandra Hoffman, and Heidi McCutcheon are seeking appointment to the Lodging Tax Advisory Committee.
 - 4.1.7 The Shelton-Mason County Chamber of Commerce expressed support of the Economic Development Council's request for .09 monies.

Cmmr. Ring Erickson asked the Health Director to elaborate on item 4.1.1 because there have been conflicting reports regarding Pickering Passage.

Vicki Kirkpatrick explained that two letters were received. One announcing an upgrade and the other announcing a downgrade. It may be for different portions of Pickering Passage, however she hasn't received confirmation from the State Department of Health regarding the issue yet.

- 4.2 Emmett Dobey, Utilities and Waste Management, read a news release announcing that a public hearing is scheduled for May 3, 2011 to consider amendments to the Solid Waste Management Plan.
- 4.3 Charlie Butros, Public Works, announced that the county road vegetation control program would begin on or after May 2, 2011.
- 5. Open Forum for Citizen Input There was no citizen input.
- 6. Adoption of Agenda Cmmr. Sheldon/Lingle moved and seconded to adopt the agenda as published. Motion carried unanimously. RE-aye; S-aye; L-aye.
- 7. Approval of Minutes February 28, 2011 briefing meeting minutes and April 5, 2011 regular meeting minutes.

Cmmr. Lingle/Sheldon moved and seconded to approve February 28, 2011 briefing meeting minutes and April 5, 2011 regular meeting minutes. Motion carried unanimously. RE-aye; S-aye; L-aye.

8. Approval of Action Agenda:

- Approval for the Equipment Rental & Revolving Fund Manager to call for bids to furnish Mason County with two used Gradall XL4100 Series 3 excavators for Public Works. Date and time of opening to be May 11, 2011 at 9:00 am.
- Approval of grant agreement G0900139 with the Department of Ecology and amendment No. 2 to said grant agreement for the development of the on-site food waste composting system for the Washington Corrections Center in the amount of \$118,313. There are no matching fund requirements.

Because Mason County is no longer involved with the Hartstene Pointe Water & Sewer system, this agreement allows the county to assign the claim proceeds from the insurance company to the water/sewer district
- Approval to award funding to the Mason County Economic Development Council (EDC) from the Rural County Sales & Use Tax Fund (.09) for business retention, expansion, recruitment project and economic development planning, as allowed in RCW 82.14.370. The EDC has applied for \$68,000 for 2011, 2012 and 2013.
- Approval of the County Road Projects 1951 through 1958, County Run-Off and Intersection Safety Road Projects, 2010 County Road Safety Program and authorize Public Works to advertise, set bid opening dates, and award contracts. Contract awards will be announced during a regular meeting of the Board. **Resolution Nos. 18-11 through 25-11** (Exhibits A through H)
- 8.7 Approval of the resolution authorizing conveyance and dedication of road right of way to the public for replacement and maintenance of the Weaver Creek bridge on Skokomish Valley Road. **Resolution No. 26-11 (Exhibit I)**

- 8.9 Approval for the Chair to sign the Interlocal Agreement between Mason Transit, Port of Shelton, Mason County, and Shelton School District for reimbursable work, supplies and/or rental of equipment from the other parties as they find mutually beneficial.
- 8.10 Approval of Consolidated Contract C14956 Amendment 29 to increase the maximum consideration of the contract by \$2,500 for a total of \$2,836,736 for the Drinking Water Group A program.
- 8.11 Approval to appoint Ross Gallagher to the Lewis-Mason-Thurston Area Agency on Aging Advisory Council representing Mason County for a two year term ending May 31, 2013.
- 8.12 Approval of Warrants
 Claims Clearing Fund Warrant #s 185614-185993 \$3,342,916.81

Tom Davis asked that item 8.5 be removed for further consideration.

Cmmr. Lingle/Sheldon moved and seconded to approve Action items 8.1 through 8.12, with the exception of item 8.5. Motion carried unanimously. RE-aye; S-aye; L-aye.

Item 8.5

An audience member asked if the requested amount is for each year or the total for all three years.

Matt Matoyoshi, Economic Development Council, explained that the request is for \$68,000 for each year, for a total \$204,000. If the award were received for this year, it would make up 31% of the Council's budget. The rest of the budget is made up of funding from businesses and other government entities.

An audience member asked if there are any public hearings for the proposals the EDC comes up with.

Cmmr. Sheldon responded that the Economic Development Council is an associate development organization. Each county in the state receives some funding for these types of organizations. He doesn't believe they are required to have public hearings for their proposals, but their meetings are open to the public. They are a 501c(6) organization.

Cmmr. Ring Erickson asked if the City of Shelton has cut back their contribution.

Mr. Matoyoshi replied that the City did cut back their contribution, but they are the exception. He noted that the PUD has increased their contribution. He also discussed how the EDC put together a proposal for the Department of Corrections and Mason County came back as the number one preferred site for a new reception center. The EDC coordinated the proposal with the City, the County Planning department, Sheriff's office and the fire departments. This award would help the EDC, which only has two staff members, to continue to do projects like this.

Cmmr. Lingle asked how much of the EDC's budget goes to training, travel and things of that nature.

Mr. Matoyoshi didn't have the exact numbers, but thought that travel was about \$3,000-\$5,000 of a \$214,000 budget. He noted that part of the travel budget is to meet a requirement for national training each year.

Cmmr. Sheldon asked Mr. Matoyoshi to explain where the funds would come from if the County approved his request.

Mr. Matoyoshi explained that it would come from the .09 fund, which is less than 1% of the state portion of the retail sales taxes. The funds have to go towards economic development, including infrastructure and personnel in economic development offices.

Cmmr. Sheldon clarified that the money could not be used for salaries at the County, Public Health or other things. It can only be used for economic development.

Mr. Matoyoshi stated that is correct. He realizes that there is a great need in the County's general fund, but this fund could not be used to offset other County departments.

Cmmr. Sheldon noted that it is unlike the City or Port, for example, because they do not have a .09 fund.

Mr. Matoyoshi explained that the City of Shelton's contribution comes directly out of their general fund so the EDC competes with other programs and priorities there.

Mr. Davis asked what the County's prior funding of the EDC was.

Cmmr. Ring Erickson responded that it was \$34,000 per year.

James Thomas spoke in favor of the request by the EDC. He stated that he owns a small manufacturing business and his business wouldn't be here without the EDC. Mr. Matoyoshi has been a tireless advocate for businesses in Mason County and the EDC has a critical role towards changing unemployment in the county. He went over the current unemployment rates and employment statistics and noted that graduates from Shelton High School who go off to college do not often have jobs to come back to. He hopes the Commission will give Mr. Matoyoshi the funding he needs to continue his efforts.

Bill Dewey, Taylor Shellfish, also spoke in support of .09 funding for the EDC. He stated that they are crucial in supporting businesses in the county, particularly the shellfish industry. Mr. Matoyoshi has been a wonderful advocate on a number of issues. He thanked the Board for their prior support of funding for the EDC and the Oakland Bay Shellfish Protection District.

Tom Davis was concerned that doubling the amount to the EDC seemed inappropriate at a time of economic stress. He would be more agreeable if it was performance based. He noted that the EDC doesn't advocate his vision for the county, which is residential development. He would have expected the EDC to speak out in favor of the Halls Equity project but they were silent on the issue. He doesn't feel that taking the county in the direction of more prisons, racetracks or biomass plants is conducive to his vision, so he is against the award for the EDC.

Robert Wagoner Jr., CEO for the Squaxin Island Tribe's Island Enterprises, spoke in support of the request by the EDC. He represents the business side of the community and he thinks it's important for the County to have a voice to talk about economic development. It would be difficult for the Commissioners to take a strong stand for all economic development. He also believes it is important to increase funding for the EDC because of the current state of the economy. It is important to make investments at the right time in an economic cycle to help swing things in the right direction.

John Cox stated that in light of the role that the EDC played in the Adage project he opposes an increase in their funding in order to minimize the damage they might do to the community in the future.

Bob Love provided a letter of support for the EDC's funding application. He is a member of the Board of Directors for the EDC and has a small custom cabinet shop in Mason County. He doesn't know of any other organization that works as hard as the EDC for everyone in the county. They bring all of the different organizations together to help make Mason County a good place to live.

Cmmr. Sheldon stated that he retired from the EDC seven years ago and has been involved with the EDC Board for a long time. He thinks Mr. Matoyoshi does a fabulous job and knows the law. The law says that the County receives \$600,000 for infrastructure development. It is fortunate that the funding continues to be provided by the Legislature. He doesn't know of any EDC that concentrates on residential development because residential development follows good jobs. He noted that the County has to be the biggest player in economic development because it represents 83% of the population. The City of Shelton only represents about 9,000 people. The newest project the EDC is working on is to hang on to the reception center for Washington Corrections. It would save current jobs, add new jobs and it would be a 125 million-dollar investment in the community. It also provides jobs for a wide variety of people. He feels strongly about this and thinks it is appropriate to make a commitment for three years because other projects have received commitments for up to 20 years.

Cmmr. Lingle agreed that the EDC plays a critical role in the community and Mr. Matoyoshi does an excellent job. He believes the points that were made by the people in the community were well thought out, but this isn't a personal situation. It is a business situation. Particular projects don't have much of a bearing with him. The EDC was awarded \$34,000 last year and he believes there needs to be an increase because economic development runs on a reverse cycle, so the money needs to be spent when the economy is down. It is important to back businesses and encourage new business during these times. He is concerned about a three-year commitment because new Commissioners may be coming in and he doesn't want to vote for someone down the road. He believes there needs to be an increase but he doesn't know how much in this situation.

Cmmr. Sheldon noted that the County's allocation from .09 money is about \$600,000 per year. Spending about 1% of that on economic development planning doesn't seem like too much. He explained that this isn't just a governmental organization. There are 110 members and most of them are businesses and individuals committed to economic development in the county. He understands not wanting to commit a future Commission but he and Commissioner Ring Erickson will be on the Board throughout 2012 so he would revise the motion to provide funding in the amount of \$68,000 for 2011 and 2012.

Cmmr. Lingle commented that some of the hardest decisions are to look into the future. Commissioner Sheldon presented some excellent points. He was hesitant as to whether he would fully support the request but he believes the revision to a two-year period is appropriate.

Cmmr. Sheldon/Lingle moved and seconded to award funding to the Mason County Economic Development Council (EDC) from the Rural County Sales & Use Tax Fund (.09) for business retention, expansion, recruitment project and economic development planning, as allowed in RCW 82.14.370, in the amount of \$68,000 for 2011 and 2012. Motion carried. RE-nay; S-aye; L-aye.

Cmmr. Ring Erickson didn't support the motion. She stated that she is new to the Economic Development Council Board and doesn't feel like she is fully knowledgeable about all of the things that go on at the EDC. This will make the County the largest contributor by far, but the decisions are made by the EDC Board. The EDC made a good point about the reception center, but the County contributed a fair amount of staffing in preparing that proposal. She doesn't have a problem with some increase, but these are tax dollars. These tax dollars have a narrow focus but this money could be used for Oakland Bay, road access and other things. She would like to see a specific proposal on how these funds over the original \$34,000 would be spent. She can't support doubling this contribution when the County's at-will employees haven't had a raise since 2008 and the department heads are still 2% below where they were 2 years ago.

Cmmr. Sheldon thanked everyone for their comments and noted that the EDC does generate tax revenue for the county.
