- 1. Call to Order The Chairperson called the regular meeting to order at 6:01 p.m.
- 2. Pledge of Allegiance Steve Bloomfield led the flag salute.

The Chair called for a moment of silence in honor of Commissioner Jerry Lingle, who passed away unexpectedly on August 19, 2011.

- 3. Roll Call Present: Commissioner District 1 Lynda Ring Erickson; Commissioner District 2 Tim Sheldon. Commissioner District 3 vacant.
- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The Washington State Liquor Control Board sent notice of a special occasion liquor license application for the Boys and Girls Club of South Puget Sound and notice of establishments in Mason County with liquor license due to expire on November 30, 2011.
 - 4.1.2 The Board of Skamania County Commissioners is seeking reimbursement of dues for the Partnership for Rural America Campaign.
 - 4.1.3 The Thurston Mason Regional Support Network released their 2010 annual report.
 - 4.1.4 S. Gordon Craig is seeking appointment to the Mental Health Task Force.
 - 4.1.5 Brian, Helen and Kyle Fulwiler and Mike Sauve expressed concerns regarding the proposed Potlach sewer project.
 - 4.2 Brian Matthews, Public Works, read a news release announcing that a ceremony for the new Capital Hill Road opening would take place on August 30, 2011.
 - 4.3 Cmmr. Ring Erickson announced that a funeral service for Commissioner Lingle was scheduled for Sunday, August 28th at 10:00 a.m. The County will also hold a memorial service for Commissioner Lingle on Tuesday, August 30th at 3:30 p.m. She noted that County business would continue as usual with two commissioners.

Cmmr. Sheldon expressed his appreciation of Commissioner Lingle's service to the county and went over the process of filling the vacant commissioner position. He explained that the Board would have 60 days to fill the position. If the two Commissioners cannot agree on an individual to fill the position it would go to the Governor. The appointed person must live in the old district 3 and would serve until the 2012 election is certified. To run for office in 2012 the candidate would have to live in the new district 3. The Commissioners are seeking a person representing an independent point of view, as Commissioner Lingle had, not a partisan individual. An advisory group may be formed to help with the process.

Cmmr. Ring Erickson noted that full details of the process would be worked out after the memorial services.

Public Testimony

Gorden McKay testified that in light of recent events at the Belfair Water District, it has been made clear that the manager is the district. Mr. Tipton has regularly ignored certified mail and public records requests. He is an employee of the district and is not held responsible for his actions. The customers are held responsible and are the district, but the customers have never been allowed any discussion or input on the annexation. It has been solely through the employee of the district. There have been many attempts to ask questions about the proposed annexation and no one is allowed to speak in the audience at the district meetings. If the customers were allowed to ask questions they would have answers regarding the construction of the water lines and other issues. He requested that the consideration of the annexation be removed until the customers of the district have had their questions answered.

Ken VanBuskirk commented that in April he put in a public records request to the water district so he could make informed comments about the annexation. He had to obtain an attorney and sue the district to obtain those records and the issue is still in litigation. He went over the Commissioners' meeting minutes and there were some things to be pointed out. The manager stated that the annexation was approved unanimously but it was actually a two to one vote. He has a lot of lingering questions about the annexations. He believes the staff report is inaccurate about phase two and phase three of the sewer. The Capital Facilities plan is scheduled to come back to the Planning Advisory Commission meeting next month and he was hoping the annexation could be held until that plan was looked at or the Belfair Water District has new commissioners.

Pat Loudin thought that the people should know where the water lines are going to go. He also doesn't believe that the properties are contiguous because there is a railroad that goes between them that belongs to the Navy. There are four individual properties that are not contiguous. Mr. Tipton has said it would be up to the developer to provide access to the developments and that isn't possible. He thinks this needs to be done right so there isn't another lawsuit. He would like to see an engineered drawing of where the water lines will be.

Cmmr. Sheldon explained that State law says that the Commissioners have 60 days to make a determination and there are certain criteria to be used to make that determination. He went over the three criteria to be considered. This annexation would expand the service area of the Belfair Water District and he doesn't believe that service is currently adequate within the district. There could be portions of the service area with inadequate pressure or portions of the service area that are not being served. The Growth Management Act talks about ensuring adequate public facilities to support development at the time the development is ready for occupancy and he doesn't think the water district is there yet. He also thinks it is unusual to annex two parcels, one after another, in order to make them contiguous. The Comprehensive Plan also speaks about the Belfair Urban Growth Area. It states that there should be future urban development that is not precluded by uncoordinated development. The criteria for adequate planning isn't met if the development appears to uncoordinated. He urged the Belfair Water District to answer outstanding questions and then reapply.

Cmmr. Ring Erickson asked if the parcels are in the Urban Growth Area.

Barbara Adkins, Department of Community Development, responded that they are.

Cmmr. Ring Erickson asked if there is water adequacy information to indicate that there is water available to serve the areas proposed for annexation.

Ms. Adkins replied that there is not.

Cmmr. Ring Erickson thought it was important to look at a professional, dependable level of service and infrastructure in the development of a community. She has had discussions about what attracts businesses to an area and she believes that quality services show businesses that their commercial investments are secure. She lacks that confidence in this proposal.

Cmmr. Sheldon/Ring Erickson moved and seconded to deny the Belfair Water District #1's request for annexation of Blue Star Properties LLC (parcel numbers 12321-13-00010 and 12321-10-01000) and Riverhill Properties LLC (parcel numbers 12321-24-00020 and 12321-21-00000). Motion carried unanimously. RE-aye; S-aye. Resolution Nos. 55-11 & 56-11 (Exhibits C & D)

- 10. Other Business (Department Heads and Elected Officials) -
 - 10.1 Sheriff Salisbury noted that the law enforcement community was also mourning the loss of Commissioner Lingle because he was sergeant in the police force before becoming a county commissioner.

 - 10.3 Cmmr. Sheldon asked the Department of Community Director to look into the change of tenant procedures to make sure they are being applied consistently.

WHEREAS, to meet the requirements of the County Road Administration Board (CRAB), a new road number must be assigned to the road, while retiring the old Capital Hill Road number.

RESOLUTION NO. 5411 AMENDING RESOLUTION 64-10 HEALTH INSURANCE CONTRIBUTIONS FOR ELECTED OFFICIALS AND NON-UNION EMPLOYEES

WHEREAS, RCW 36.40.080 states that ... the Board of County Commissioners shall fix and determine each item of the budget separately and shall by resolution adopt the budget...,

WHEREAS, RCW 36.16.070 states that ... the Board shall fix the compensation of all employees...,

WHEREAS, the Board has determined that the County's contribution towards health insurance premiums for Elected Officials and eligible Non-Union employees should be adjusted;

NOW THEREFORE BE IT RESOLVED, effective January 2012, the Board of County Commissioners does hereby establish the County's health insurance contribution rate for Elected Officials and eligible Non-Union Employees as follows:

\$683 per month per Elected Official/Employee for those individuals enrolled on medical as an employee only (no dependent coverage). This contribution also covers dental, vision, basic life and basic long-term disability insurance.

\$951 per month per Elected Official/Employee for those individuals enrolled on medical as employee with one or more dependents. This contribution also covers dental, vision, basic life and basic long-term disability insurance.
