- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The Washington State Department of Natural Resources sent their projection of income from State Forest Lands.
 - 4.1.2 The Washington State Liquor Control Board sent notice of an application for added privilege for Alderbrook Golf and Yacht Club.

 - 8.2 Approval to establish Parks and Facilities Scheduler position in the Parks, Trails and Facilities Department. This is to allow a partial restructure of the department and will be funded from budgeted positions that are not filled.
 - 8.3 Approval of the Veterans Assistance Fund application for: Claude H. Harley (Elder) Housing \$600.00; Robert Ramar (Diane) Utilities \$156.97; Robert F. May Housing \$575.00 for a total of \$1,331.97 as recommended by the Veterans Assistance Fund Screening Committee.
 - 8.4 Approval to call for bids for the Belfair Sanitary Sewer Lateral Improvements County Hood Up Program. This is for individual connections to the Belfair Sewer System. The bid opening date will be Thursday, November 17, 2011 at 3 p.m.

- 8.6 Approval of Amendment No. 3 to the Coordinated Prevention Grant Agreement G1000392 between Washington State Department of Ecology and Mason County for the Mason County Solid Waste Program. This is to provide continued funding in the amount of \$43,955 over the next six months with a 25% match of \$10,991 that is provided by a solid waste tipping fee. The contract and match are budgeted for 2011.
- 8.7 Approval of Amendment No. 10 to the Department of Ecology Grant No. G0800033 for the WRIA 16/14B-Phase 4 project. This increases the maximum consideration of the contract by \$75,000 to a total maximum of \$530,170 with an in-kind match of \$8,333.
- 8.8 Approval to sign the Notice of Approval to Hear Property Tax Appeals authorizing the Board of Equalization to convene for the purpose of hearing property tax appeals for the current year, pursuant to RCW 84.48.010.
- 8.9 Approval of voicing no objections to the Hoodsport Winery application to the Washington State Liquor Control Board for an added privilege of beer/wine specialty shop.
