## **BOARD OF MASON COUNTY COMMISSIONERS' PROCEEDINGS**

## June 26, 2012

- 1. Call to Order The Chairperson called the regular meeting to order at 6:01 p.m.
- 2. Pledge of Allegiance Mark Core led the flag salute.
- 3. Roll Call Present: Commissioner District 2 Tim Sheldon; Commissioner District 3 Steve Bloomfield. Absent: Commissioner District 1 Lynda Ring Erickson.
- 4. Correspondence and Organizational Business
  - 4.1 Correspondence
    - 4.1.1 The Washington State Liquor Control Board sent notice of a special occasion liquor license application for the Pacific NW Tejano Music Association and notice of assumption for Ben's Deli Mart in Allyn.
    - 4.1.2 The Olympic Region Clean Air Agency sent notice of Mason County's assesment for calendar year 2013.
    - 4.1.3 Gerald Hard asked the Board to expedite their approval of Wilson Recycling's request to accept garbage.
  - 4.2 Cmmr. Sheldon noted that there was a large explosion of a container of fireworks in Belfair. There was no county permit for the container and the incident is being investigated.
  - 4.3 Tom Moore, Utilities & Waste Management, announced the award of the Belfair Sewer Get Connected Phase 1 pressure sewer project to Pape & Sons Construction of Gig Harbor, Washington in the amount of \$330,683.49, including the base bid of \$226,099.17 and additive alternates in the amount of \$104,584.32.
  - 4.4 Mr. Moore also announced the award of the Belfair Sewer Get Connected Phase 1 gravity sewer project to Sound Excavation, Inc. of Bremerton, Washington in the amount of \$569,959.84, including the base bid of \$475,036.21 and additive alternates in the amount of \$94,926.63.
- 5. Open Forum for Citizen Input -
  - 5.1 Tom Davis commented on the County's solid waste hauling contract. He felt it should have gone through the open bidding process. He was concerned that processes weren't being adhered to.
  - 5.2 Tom Wehneat stated that on April 26<sup>th</sup> he and his neighbor were burglarized. The deputy he talked to told him it was a low priority and he would be out of luck on getting any justice. His wife was able to locate the suspect in Kitsap County and the Kitsap County detectives arrested him right away. He wanted to know how to solve the funding issues that were causing response problems in the Sheriff's office.

Cmmr. Sheldon noted that the Sheriff's office budget had been increased 24% since he had been in office. He explained that the Sheriff was an elected official so the Commissioners didn't have any control over his operations.

Cmmr. Bloomfield added that the issue was a particularly sore spot for him.

Cmmr. Sheldon recommended that Mr. Wehneat check with the Superior Court to find out the process for pressing charges.

6. Adoption of Agenda - Cmmr. Bloomfield/Sheldon moved and seconded to adopt the agenda as published. Motion carried unanimously. RE-absent; S-aye; B-aye.

  - 8.2 Approval of Amendment No. 1 to the Agreement between Mason County and J. A. Cunningham Consulting, LLC for the provision of interim professional staff support for the Public Works Department extending the end date of said Agreement to October 31, 2012 with the possibility of a further extension to December 31, 2012 at the County's discretion and authorize execution of said Amendment No. 1 by the Mason County Public Works Director.
  - 8.3 Approval of the resolution for the distribution of the Public Utility District Excise Tax, per RCW 54.28.090. The Mason County Current Expense Fund will receive \$522,411.35 and the City of Shelton will receive \$71,661.79. **Resolution No. 53-12 (Exhibit A)**
