RESOLUTION NO. <u>46-1</u>Z A RESOLUTION TO RESTRICT THE USE OF RESOURCES IN THE MENTAL HEALTH FUND #164-000-000

WHEREAS, Mason County has established Fund Number 164-000-000 to receive resources for the purpose of provision of Mental Health and Substance Abuse prevention and treatment services; and

WHEREAS, Mason County Board of Commissioners passed Resolution #75-11 imposing a one-tenth of one percent sales and use tax authorized by RCW 82.14.460(2) for Mental Health and Substance Abuse Prevention and Treatment Services and Therapeutic Courts; and

WHEREAS, RCW 82.14.460(3) provides that monies collected shall be used solely for the purpose of providing new or expanded substance abuse or mental health services and for the operation of new or expanded therapeutic court programs; and

WHEREAS, in addition to the new one-tenth of one percent sales and use tax authorized via Resolution #75-1, Mason County also levies a property tax for the provision of mental health and developmental disability services (BARS Code 311.10.00.0000); and

WHEREAS, historically other revenues generally tied proportionately to the property tax levy are also placed into Fund #164-000-000 as follows:

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Mason County hereby requires that all funds placed into Fund #164-000-000 be used solely for mental health, developmental disability, substance abuse prevention and treatment services and therapeutic courts and the management thereof and

BE IT FURTHER RESOLVED that no transfer of resources from Fund 164-000-000 shall be made to another county fund unless it is for the express purposes of the Fund – mental health, developmental disability, substance abuse prevention and treatment services and therapeutic courts and the management thereof.
