- 1. Call to Order The Chairperson called the regular meeting to order at 9:01 a.m.
- 2. Pledge of Allegiance Frank Pinter led the flag salute.
- 3. Roll Call Present: Commissioner District 1 Lynda Ring Erickson; Commissioner District 3 Steve Bloomfield. Absent: Commissioner District 2 Tim Sheldon.
- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The Washington State Liquor Control Board sent notice of establishments in Mason County with liquor licenses due to expire on December 31, 2012, notice of an application for added privilege for QFC in Belfair, and notice of a special occasion liquor license application for the North Mason Coalition of Churches & Community.
 - 4.1.2 The Washington State Department of Archaeology and Historic Preservation announced that the Mason County Courthouse is being reviewed for nomination to the National Register of Historic Places.
 - 4.1.3 The Economic Development Council of Mason County provided their third quarter report.
 - 4.1.4 Edward M. Kruk is seeking appointment to the Belfair Urban Growth Advisory Committee.
 - 4.2 Staff Recognition Public Works. Cmmr. Ring Erickson recognized Karen Dowling for earning the Professional Finance Officer Award.
 - 4.3 Vicki Kirkpatrick, Public Health, read a news release announcing new public hours for the Mason County Public Health & Human Services department.
 - 4.4 Cmmr. Bloomfield read a news release announcing vacancies on the Mason County Housing Authority Commission.
- 5. Open Forum for Citizen Input
 - John Piety, Mason County Democrats, read a resolution from the Democrats regarding the County Commissioners' salaries. They requested that the Board act prior to November 6th to return the salary levels to that of 2008. A copy of the resolution was provided for the record.
 - 5.2 Tom Davis went over the Commissioners' attendance and meeting availability. He also commented on the Commissioners' salaries. He thought the salaries were out of line and he encouraged the Board to find a way to reverse the salary increases.
 - Patricia Vandehey clarified her comments from September 4th. Her concern was regarding the disposal of sediment to an unknown site and the lack of information she was able to receive from the Health Department. She also discussed the Growth Management Act's requirements to protect critical areas. She would like to know why the mapping of critical areas had not been done.
 - Annette McGee discussed her comments from September 11th. Her questions about the Port's authority to change the land use designation of the fairgrounds property hadn't been answered and she wanted to know when she would receive the information.

 - 10.3 Cmmr. Bloomfield discussed Commissioner meeting attendance requirements and having respectful discussions with the Board under the public comment portion of the agenda.
 - 10.4 Cmmr. Ring Erickson discussed the Commissioners' salaries. She noted that only two of the Commissioner districts could be changed because district three was still in the middle of a term. The current Commissioners did not pass the resolution that established the salary increases. She went over the ways the Commissioners have given back their salary increases and reduced their budget. She felt the Commissioners salaries should be tied to the exempt at-will employees. She also discussed Commissioner meeting attendance. State laws set the attendance requirements. She noted that when the Commission is scheduled to meet 52 times per year there would be some absences.
