### January 15, 2013

- 1. Call to Order The Chairperson called the regular meeting to order at 9:03 a.m.
- 2. Pledge of Allegiance Frank Pinter led the flag salute.
- 3. Roll Call Present: Commissioner District 1 Randy Neatherlin; Commissioner District 2 Tim Sheldon; Commissioner District 3 Terri Jeffreys.
- 4. Correspondence and Organizational Business
  - 4.1 Correspondence
    - 4.1.1 The Washington State Liquor Control Board sent notice of establishments in Mason County with liquor licenses due to expire on February 28, 2013.
    - 4.1.2 Comcast sent notice of rate changes effective February 1, 2013.
    - 4.1.3 John Gunter is seeking appointment to the Planning Advisory Commission.
  - 4.2 Cmmr. Sheldon read a proclamation regarding Mason Transit Authority's 20-year anniversary.
  - 4.3 LaJane Schopfer, Department of Community Development, read a news release announcing upcoming public workshops to review the Shoreline Master Program draft policies and regulations.
- 5. Open Forum for Citizen Input -
  - 5.1 Patricia Vandehey suggested including discussion regarding the loss of shorelines due to global warming during the public workshops on the Shoreline Master Program.
  - 5.2 Steve Bloomfield asked the Board to consider the condemnation of the current fairgrounds as the least expensive option for the future fairgrounds. He also noted that the zoning issues needed to be addressed because the County should zone the land, not the Port or FAA.
  - 5.3 Tom Davis noted that the seating was uncomfortable in the Commission Chambers. He asked that the item be addressed at a future briefing.

8.6 Approval for the Chair to execute an Inter-Governmental Request and Agreement for Reimbursable Work by Mason Conservation District to provide environmental services, as needed, for calendar year 2013.

8.7 Approval for the Chair to execute the Local Agency Federal Aid Project Prospectuses approved Federal Highway Administration (FHWA) funding for County Road Projects (CRP) 1954 – Lynch Road/Arcadia Road, CRP 1955 – Matlock Brady Road/Schafer Park Road and CRP 1956 – Pickering Road/Harstine Bridge Road and authorize the Chair to sign all other pertinent documents for these projects.

8.8 Approval for Public Works to select from the County MRSC Consultant Roster and enter into agreements for Structural, Geotechnical, Hydraulic, Archaeological and Cultural Resource consultant services, as needed for 2013-2014 calendar years. The maximum pay-out for each agreement is not to exceed \$50,000; Public Works will announce each consultant selection during a regular scheduled Commission meeting.

8.9 Approval to designate Robert Deans as the Mason County Adobe Agency Coordinator, Ben Ramsfield as Backup Coordinator and authorize the Chairperson to execute the Adobe Products Purchase Agreement with the Washington State Department of Enterprise Services.

8.10 Approval for the Equipment Rental & Revolving (ER&R) Fund Manager to purchase one new 2013 utility 4x4 vehicle from the Washington State contract to replace vehicle #171 that was damaged. Cost is approximately \$27,000 plus tax and will be funded from the ER&R Fund.

Tom Davis asked why the project was under budget and who engineered the project.

Tom Moore, Utilities and Waste Management, explained that they didn't need as much imported backfill or asphalt as was planned. ESA was the engineer.

Cmmr. Sheldon left the meeting at 9:30 a.m.

#### Item 8.10

Mr. Davis noted that the County was self-insured for collisions. He wondered if purchasing a collision policy would be cheaper.

Dave Loser, Equipment Rental and Revolving Fund, explained that the County had paid for auto insurance in the past and it was very expensive, especially for the Sheriff's vehicles. He could only remember approximately two vehicles being destroyed in the past 10-15 years. Being self insured has worked well for the County.

Cmmr. Jeffreys/Neatherlin moved and seconded to approve action items 8.1 through 8.10. Motion carried unanimously. N-aye; S-absent; J-aye.

## RESOLUTION NO. 02 - 13

A RESOLUTION of the Mason County Board of Commissioners accepting the Belfair Sewer Project's County Hook-up Program Group #2 Project as complete.

WHEREAS, the Board of County Commissioners of Mason County (Board) approved the Belfair Wastewater Treatment and Water Reclamation Facility project for the Belfair Urban Growth Area (UGA); and

WHEREAS, the Board has previously declared that the primary means of sewage collection and disposal in the Belfair UGA area shall be through construction and connection to the County's permanent sewer collection system and treatment facilities; and

WHEREAS, a part of construction of the Belfair Wastewater Treatment and Water Reclamation Facility project included construction of sewage collection main lines within the Phase 1 area of the Belfair UGA; and

WHEREAS, the Board has adopted regulations requiring that existing developed parcels of property located within the Belfair UGA and within 500 feet of the alignment of the Belfair wastewater and reclamation facilities pipeline connect to public sewer facilities as soon as sewer service is available; and

WHEREAS, the Board created and funded the County Hook-up low interest loan Program to assist property owners with existing structures within Phase 1 of the Belfair sewer project area with the cost of their required connection to the Belfair sewer system; and

WHEREAS, at their January 10, 2012 regular meeting, the Board authorized the Utilities and Waste Management Department to advertise and award the contract for construction of the Belfair Sewer County Hook-up Program Group #2 Project; and

WHEREAS, on February 1, 2012, a total of 5 responsible and responsive bids for the Belfair Sewer County Hook-up Program Group #2 Project were publically opened and read aloud; and

WHEREAS, on February 29, 2012, the Utilities and Waste Management Department awarded the contract for construction of the Belfair Sewer County Hook-up Program Group #2 Project to Zephyr, Inc., the lowest responsible & responsive bidder on the project, in the amount of \$172,006.36; and

WHEREAS, the County Hook-up Program Group #2 Project has been completed for a total construction cost of \$163,026.61; and

WHEREAS, the County Hook-up Program Group #2 Project has been completed in accordance with the project plans and specifications; and

WHEREAS, the County Hook-up Program Group #2 Project has been approved by representatives of ESA, Inc., the project's Project Engineer of Record, and the County's Department of Public Works, Utilities & Waste Management Division; and

WHEREAS, no contractor claims have been filed against Mason County relative to the County Hook-up Program Group #2 Project;

NOW THEREFORE, BE IT RESOLVED, that the Mason County Commissioners hereby accept the Belfair Sewer Project's County Hook-up Program Group #2 Project as complete.

BE IT FURTHER RESOLVED, that the Deputy Director of the Utilities & Waste Management Division of the Mason County Public Works Department is hereby authorized to complete the contract closure process upon receiving appropriate releases from the Department of Revenue, Department of Employment Security and Department of Labor and Industries.

WHEREAS, the County Hook-up Program Group #3 Project has been completed for a total construction cost of \$125,426.22; and

WHEREAS, the County Hook-up Program Group #3 Project has been completed in accordance with the project plans and specifications; and

WHEREAS, the County Hook-up Program Group #3 Project has been approved by representatives of ESA, Inc., the project's Project Engineer of Record, and the County's Department of Public Works, Utilities & Waste Management Division; and

WHEREAS, no contractor claims have been filed against Mason County relative to the County Hook-up Program Group #3 Project;

## RESOLUTION No. OI-12

### **AMENDS RESOLUTION 71-11**

IN THE MATTER OF CONTINUING RELATIONSHIPS WITH THE WASHINGTON COUNTIES RISK POOL AND THE RELATED APPOINTMENTS AND DESIGNATIONS OF/FOR EACH MEMBER COUNTY.

**WHEREAS**, several Washington counties agreed to the creation of the Washington Counties Risk Pool ("Pool"), organized and operating under Chapters 48.62 and 39.34 RCW, to provide to its member counties programs of joint self-insurance, joint purchasing of insurance, and joint contracting for or hiring of personnel to provide risk management, claims handling, and administrative services; and

**WHEREAS,** the Pool's Interlocal Agreement and Bylaws, and policies of its Board of Directors require appointees and/or designees from each member county; that is:

- a) **Director / Alternate Director** officers or employees of each Pool member county that are appointed by and serve at the pleasure of the respective county's legislative authority (Article 8 of the Interlocal Agreement and Article 2 of the Bylaws);
- b) **County Risk Manager** an employee of each Pool member county appointed to serve as a liaison between the County and the Pool as to risk management and who is responsible for the risk management function within the County (Article 11(b) of the Interlocal Agreement);
- c) **County Safety Officer** an active employee designated by each Pool member county who, along with a related committee, are maintained to consider all recommendations concerning the development and implementation of a loss control policy to prevent unsafe practices (*Article 11(c)* of the *Interlocal Agreement*); and
- d) **County Claims Administrator** each Pool member county's must designate someone to administer civil claims, with whom incidents should be immediately reported to, who is responsible for sending all claims and lawsuits and reporting various known incidents to the Pool, and with whom the Pool will coordinate the County's clams administration (section B of the Pool Board of Directors' Claims Handling Policies and Procedures);

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners for Mason County hereby confirms the appointment or designation of the following individuals for the applicable and required relationships with the Washington Counties Risk Pool:
