- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 Washington State University thanked the Board for their continued support of the Washington State University Extension Program in Mason County.
 - 4.1.2 The Timberland Regional Library is seeking concurrence of Lewis County's appointment of Regina King and Hal Blanton to the Timberland Regional Library Board.

Item 8.6

Tom Moore, Utilities and Waste Management, explained that a form was received today from the EPA for the final reimbursement for the Belfair sewer. It certifies that the money received from the grant wasn't used to lobby or sue the federal government.

Cmmr. Jeffreys/Neatherlin moved and seconded to approve action item 8.6. Motion carried. N-aye; S-absent; J-aye.

- 9. 6:30 p.m. Public Hearings and Items Set for a Certain Time There were no public hearings scheduled.
- 10. Other Business (Department Heads and Elected Officials) -
 - 10.1 Public Comment on Financing Recommendations for Fairgrounds and Future Fairground Possibilities and Report from the Fairgrounds Fiscal Feasibility Advisory Committee.

John Keates, Facilities Parks and Trails, provided a copy of the Fairgrounds Fiscal Advisory Committee's report. He discussed the committee's work and answered questions from the audience regarding the report.

Public Testimony

Tom Davis noted that there are already event centers at the casinos in the county so the plan for a new event center would make little business sense. He thought the fairgrounds should remain in the existing location.

Rhoda Pykonen felt it was important to restore and repurpose historical buildings in the community. She thought the fairgrounds buildings could be used for aeronautical or county history museums.

Debra Soper discussed other fairgrounds in the state. She thought the Board should consider starting with a small fairgrounds if the location cannot remain at the Port.

Norm Eveleth stated that the County should have never put the fairgrounds on leased property. He urged the Board not to make that same mistake again.

Steve Bloomfield noted that the committee came up with a good list of funding sources and they were all worth looking at regardless of where the location will be.

Annette McGee thought the fair should remain at the current location. She urged the Board to work with the Port on the issue.

Jay Hupp provided the history of the fairgrounds at the Port property. He thought there could be a solution to the problem that would not harm the airport's ability to operate. It would allow the community to keep their fairgrounds if the community puts in the effort.

Marv Faughender had been a Port Commissioner, County Commissioner and has worked with Oysterfest. He was concerned that Oysterfest will leave if there are no fairgrounds, which would be a big loss for the community.

Ms. McGee was concerned about the county's representation of the cost of the fair. She thought the community would get behind the fair again if they had the opportunity.

Cmmr. Neatherlin stressed the importance of community involvement if there is to be a fair in the future because the county does not have the money to fund it. It will take a creative partnership to make it work.

Cmmr. Jeffreys was interested in discussing the issue with the Port Commissioners. She had difficulty in finding the county's role in the fair. She agreed that a new facility should start small.
