- 1. Call to Order The Chairperson called the regular meeting to order at 9:03 a.m.
- 2. Pledge of Allegiance Chief Jan Alvord led the flag salute.
- 3. Roll Call Present: Commissioner District 1 Randy Neatherlin; Commissioner District 2 Tim Sheldon; Commissioner District 3 Terri Jeffreys.
- 4. Correspondence and Organizational Business
  - 4.1 Correspondence
    - 4.1.1 The Washington State Liquor Control Board sent notice of a new liquor license application for Seabeck Pizza in Belfair and notice of special occasion liquor license applications for Harstine Island Community Club and Squaxin Island Library Research Center.
    - 4.1.2 The Washington State Department of Commerce is requesting the County's designation of an Associate Development Organization for the 2013-2015 biennium.
    - 4.1.3 The Federal Emergency Management Agency provided a follow up to their National Flood Insurance Program Community Assistance Visit.
    - 4.1.4 The Shelton Mason County Chamber of Commerce, Economic Development Council of Mason County and Olympia Master Builders of Mason County submitted comments on the Shoreline Master Plan.

  - 8.1 Approval to authorize the Chair to sign the Sole Source Justification Form allowing Utilities Department to move forward with the purchase of a grapple assembly for the Grizzley Crane at the Solid Waste Transfer Station.
  - 8.2 Approval of Veterans Assistance Fund applications for: Utilities \$382.87; Housing \$600.00 for a total of \$982.87 as recommended by the Veterans Assistance Screening Committee.
  - 8.3 Approval of a Client Service Contract between Mason County Office of Public Defense and Pat Lewis to provide legal representation of indigent defendants in adult criminal matters in Mason County District Court. This is to fill a vacated position. Contract term is May 1, 2013 through December 31, 2013 with a base compensation of \$4,000 per month.
  - 8.4 Approval for the Chair to sign all pertinent documents for the 2013 for the Manufacturing and Stockpiling of Chipseal Aggregate and authorize for Public Works to re-advertise, set bid opening date/time and award contract. Contract awards will be announced during a regular meeting of the Board.

John Keates, Facilities and Parks, explained that the Treasurer's office recently conducted a tax sale for properties in foreclosure. There were a number of properties that were not sold. He would like to declare those properties surplus so they can be sold via other means.

- Mr. Davis asked if the County would assume liability for properties that might be contaminated.
- Mr. Keates stated that was correct.

Mr. Davis thought the County should hold on to the properties until economic times improve. He noted that when properties are sold at a reduced price it affects the value of the other properties in the neighborhood. He recommended engaging a realtor to sell the properties.

The Board agreed that surplusing the properties would benefit the county.

Jeffreys/Sheldon moved and seconded to adopt the resolution declaring twenty-two parcels of real property to be surplus to the needs of Mason County and to approve their sale by means of a sealed bid process and other means authorized by law.
