- 4. Correspondence and Organizational Business

    - 4.1.1 The Washington State Office of Financial Management provided 2013 population estimates.

Theresia Ehrich, Chief Finance Manager, noted that the Legal Reserve Fund #2 requires a \$50,000 balance by resolution and most of the retirees using accrued leave are taking a monthly payout. She explained the process for amending the budget.

#### **Ouestions for Staff**

The Board and Ms. Ehrich responded to questions from the audience regarding the labor contract, Human Resources Director salary and membership dues.

It was clarified that all of the items were unanticipated. There is one outstanding issue on the labor contracts regarding the taxes but this should be the last of the money being paid out. The Human Resources Director was not receiving a raise. The salary was not added into the budget when it was originally changed in 2012. The changes to the dues were for various reasons. There was an increase, one item was not budgeted and one was not budgeted in the correct fund.

#### **Public Testimony**

Tom Davis felt that the last HR Director should have received the increased salary and the room that the current Director is receiving.

Annette McGee didn't think that all of the items were unanticipated. She also thought that the situation with the last HR Director was questionable.
