- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The Washington State Liquor Control Board sent notice of special occasion liquor license applications for Allyn Community Association and Huerfanitos International.
 - 4.1.2 Wayne Olson expressed concerns regarding the Squaxin Island Tribe's application to acquire land in trust in the Arcadia Point area.
 - 4.1.3 Susan Noyes-Mathers wrote in support of limiting garage sales in Mason County.
 - 4.1.4 Jerry Myers submitted his resignation from the Mason County Board of Equalization.
 - 4.1.5 Robert McKibben is seeking appointment to the Mason County Board of Equalization.
 - 4.2 Brian Matthews, Public Works, read a news release announcing that the first meeting of Belfair Sewer Advisory Committee would take place on July 10th.
- 5. Open Forum for Citizen Input -
 - 5.1 Tom Davis discussed poverty in the county and how it is affecting more people.
