- 4. Correspondence and Organizational Business

- 8.3 Approval of contract agreement #1363-78924 between Mason County Juvenile Court and the Juvenile Justice and Rehabilitation Administration (JJ&RA). This is for \$37,433 for each year of the 2013-2015 biennium with no match requirement. These funds are provided to support interventions and programs that have demonstrated the ability to promote greater accountability in the juvenile justice system.
- 8.4 Approval to execute the Interlocal Agreement between Mason County and the City of Shelton for reimbursable work, supplies and/or rental of equipment.
- 8.5 Approval to authorize the Public Works Director to sign the letter from Regional Disposal Company for solid waste export services for Mason County acknowledging the County's concurrence with continuing the existing contract status quo until this issue is resolved.
- 8.6 Approval for the Chair to sign Real Estate Multiple Listing Forms to facilitate marketing and selling Mason County Surplus Real Estate.
