## **BOARD OF MASON COUNTY COMMISSIONERS' PROCEEDINGS**

## September 3, 2013

- 1. Call to Order The Chairperson called the regular meeting to order at 9:07 a.m.
- 2. Pledge of Allegiance Ken VanBuskirk led the flag salute.
- 3. Roll Call Present: Commissioner District 1 Randy Neatherlin; Commissioner District 3 Terri Jeffreys. Absent: Commissioner District 2 Tim Sheldon.
- 4. Correspondence and Organizational Business
  - 4.1 Correspondence
    - 4.1.1 The Washington State Liquor Control Board sent notice of special occasion liquor license applications for Shelton Skookum Rotary Club.
    - 4.1.2 Janet O'Connor is seeking appointment to the Solid Waste Advisory Committee.
  - 4.2 Presentation of the 2014 budget requests. Auditor Karen Herr spoke about the budget process. Commissioners issued guidelines that stated departments were not to exceed their June 2013 budget level with one exception, Departments were to budget 100% of the Equipment Rental & Revolving rates and the budgets could be increased by 50% of these rates. She noted there are no salary increases for the non-represented employees and elected officials except for the Commissioners who have a 1% salary increase.

Theresia Ehrich, Chief Finance Manager, presented the 2014 budget requests. Current Expense revenues are anticipated at \$24,767,024 and expenditures are requested at \$27,032,432. \$110,000 in supplemental requests have also submitted.

Tom Davis clarified that if REET 1 and .09 funds could not meet commitments, the General Fund would have to pay.

Cmmr. Neatherlin noted that he did not vote for the 1% Commissioner salary increase and the Commissioners are working very hard to find revenues.

Cmmr. Jeffreys pointed out this is the preliminary budget and no where near final. Revenues, expenditures, and services need to be looked at to provide a good level of service that the county can afford. Her goal is to set parameters around the ending fund balance.

- 4.3 Michael MacSems noted the news release advertising for four open positions on the Historic reservation Commission was presented at last week's meeting.
- 5. Open Forum for Citizen Input -
  - 5.1 Tom Davis voiced appreciation for Cmmr. Neatherlin and Jeffreys detailed review of the budget.
  - 5.2 Steve Bloomfield talked about the Rustlewood water system, the debt owed and color of water. He encouraged the county to collect on the debt. Tom Moore explained the water is chlorinated and discoloration can occur. The system is flushed at least once a month and he will contact the operator.
- 6. Adoption of Agenda Cmmr. Jeffreys/Neatherlin moved and seconded to adopt the agenda as published. Motion carried unanimously. N-aye; S-absent; J-aye.

Cmmr. Jeffreys referred to Item 8.3 convening the Board of Equalization. The Clerk of the Board resigned and the timeline to hold the hearings is unknown, however the Commissioners can appoint a Clerk.
