- 4. Correspondence and Organizational Business
 - 4.1 Correspondence
 - 4.1.1 The United States Bureau of Indian Affairs sent notice of an additional 30-day comment period for the Squaxin Island Tribe's application for acquisition of property on Arcadia Point.
 - 4.1.2 The Federal Aviation Administration provided a response to the Commissioners' July 17th letter regarding the non-aeronautical use of airport property at Sanderson Field.
 - 4.1.3 Comcast sent notice of rate changes effective October 1, 2013.
 - 4.2 Cheryl Heywood, Library Director, provided an overview of new Timberland Regional Library programs.
- 5. Open Forum for Citizen Input -
 - 5.1 Patricia Vandehey discussed a CARA grant from the State Department of Health. She thought that the Department of Community Development should be handling the grant work instead of the Health Department because of the focus on zoning and mapping.

 - 8.2 Approval for the Chair to sign an agreement with Murphy Company Logging providing authorization for Murphy Company to harvest timber on seven parcels of county owned property (154.98 acres). Murphy Company was the successful bidder for the sale on May 9th, 2013. Purchase price of the timber payable to Mason County is \$1,254,991.32.
 - Approval of the Veterans Assistance Fund applications for: Food \$300.00; Utilities \$135.46; and Housing \$600.00 for a total of \$1,035.46 as recommended by the Veterans Assistance Fund Screening Committee.
 - 8.4 Approval to sign a letter of support for the Forest Legacy Program funding proposal of Green Diamond Resource Company and The Trust for Public Land for the purchase of conservation easements.
 - Approval the .6 FTE Program Coordinator position to serve as the Housing Coordinator effective 10/1/2013 and cancel the 2013 contract for the Housing Coordinator effective September 30, 2013.
 - Approval to appoint Dr. Diana Yu, MD, MSPH as the Mason County Health Officer effective December 1, 2013 upon completion of the contract for health officer services with Thurston County Public Health and Social Services. The annual cost is \$56,700.

The MOUs would modify the current Collective Bargaining Agreements to increase the County contribution for Health & Welfare benefits to a maximum equivalent of \$955 per employee per month effective August 1, 2013; and approval of the resolution which provides a County contribution increase for Health & Welfare Benefits to the Non-Union employees and Elected Officials to a maximum equivalent of \$955 per employee per month effective August 1, 2013. **Resolution No. 43-13 (Exhibit A)**

RESOLUTION NO. 43-13 AMENDING RESOLUTION 75-12 HEALTH INSURANCE CONTRIBUTIONS FOR ELECTED OFFICIALS AND NON-UNION EMPLOYEES

WHEREAS, RCW 36.40.080 states that ...the Board of County Commissioners shall fix and determine each item of the budget separately and shall by resolution adopt the budget...,

WHEREAS, RCW 36.16.070 states that ... the Board shall fix the compensation of all employees...,

WHEREAS, the Board has determined that the County's contribution towards health insurance premiums for Elected Officials and eligible Non-Union employees should be adjusted;

NOW THEREFORE BE IT RESOLVED, effective August 1, 2013, the Board of County Commissioners does hereby establish the County's health insurance contribution rate for Elected Officials and eligible Non-Union Employees at \$955 per month utilizing the pooling method, and resulting as follows:

\$721 per month per Elected Official/Employee for those individuals enrolled on medical as an employee only (no dependent coverage). This contribution also covers dental, vision, basic life and basic long-term disability insurance.

\$1,072 per month per Elected Official/Employee for those individuals enrolled on medical as employee with one or more dependents. This contribution also covers dental, vision, basic life and basic long-term disability insurance.
