

## BOARD OF MASON COUNTY COMMISSIONERS' PROCEEDINGS

December 17, 2013

1. Call to Order – The Chairperson called the regular meeting to order at 9:07 a.m.
2. Pledge of Allegiance – Darnell Border led the flag salute.
3. Roll Call – Present: Commissioner District 1 - Randy Neatherlin; Commissioner District 2 – Tim Sheldon; Commissioner District 3 – Terri Jeffreys.
4. Correspondence and Organizational Business
  - 4.1 Correspondence
    - 4.1.1 Received two Notice of Marijuana License Applications from the Washington State Liquor Control Board for Marijuana Processor and Marijuana Producer Tier 2 from Greenleaf Growers.
    - 4.1.2 Received letter from the Lower Hood Canal Watershed Coalition identifying actions and priorities.
    - 4.1.3 Received letter of appreciation from John & Shirley Byerly regarding Public Health Nurse Linda Bullock.
    - 4.1.4 Received letter from Bureau of Indian Affairs regarding the acquisition of a 1.45-acre tract and a 39.62-acre tract to be held in trust for the use and benefit by the Skokomish Indian Tribe.
    - 4.1.5 Received correspondence from Mary Swoboda writing in support of declining the acceptance of the Washington Wildlife and Recreation Program grant that required a 50% match from the County to renovate two infields at MCRA Park.
  - 4.2 Vicki Kirkpatrick, Mason County Public Health Director, read a letter received giving recognition to Public Health Nurse Linda Bullock for her the caring and thoughtfulness she brings to her job.
5. Open Forum for Citizen Input –
  - 5.1 Conley Watson asked for clarification on the amount of funding to Economic Development Council. Cmmr. Jeffreys confirmed the funds allocated to them were \$68,000. Mr. Watson also commented that the City of Shelton has a 10 to 15% increase on water and sewer fees. He asked the Board what the County anticipates those costs to be. Cmmr. Jeffreys confirmed it was included in the budget. Mr. Watson then asked about the retirement accounts for the County and if they were also included in the budget? Cmmr. Jeffreys commented that the retirement system is managed through the State.
  - 5.2 Mary Jean Hrbacek commented she was concerned with the lack of detail on the current expense budget and without citizens having the necessary information
  - 5.3 Tom Davis commented on a memorandum dated Nov. 26, 2013 from the Human Resources Director to the Board of County Commissioners. He commented on the new positions created and how it was proposed is unacceptable and has no benefit for public. He explained that it is not the structure, but the decisions being made that are the problem. Tom asked the Board to set aside the proposed classifications and additional expenditures for better economic times.

Cmmr. Sheldon commented that these changes will make the County more efficient by consolidating efforts by centralizing functions for supporting services.

Cmmr. Jeffreys commented on Support Services stating that it has to do with internal processes and services that we provide to all departments of the County.

Tom commented on how these were discussed and asked if they were conducted in Executive Sessions. Cmmr. Jeffreys clarified they were discussed during Central Operation briefings.

- 5.4 Karen Herr, Mason County Auditor, addressed the Board commenting on the general overview of the reorganization plan and the budget process. She asked the Board to consider postponing the adoption a week to allow the public be given a chance to comment.
6. Adoption of Agenda - **Cmmr. Shelton/Jeffreys moved and seconded to adopt the agenda as published with additions of Item 10.2 regarding a letter from the Board addressing the Fairgrounds, and the addition of Item 10.3 regarding Trust Land. Motion carried unanimously. N-aye; S-aye; J-aye.**
7. Approval of Minutes – There were no minutes presented for approval.
8. Approval of Action Agenda:
- 8.1 Approval to reappoint Corby Varness to the Timberland Regional Library Board of Trustees, representing Grays Harbor County to fill a seven-year term which ends December 31, 2020.
- 8.2 Approval to enter into an agreement with North Mason County Resource (NMCR) for the use of office space and facilities for Veterans Service Officer to provide Veterans assistance. The term is January 1, 2014 through December 31, 2014 for a total of \$600 a month to be paid from the Veterans Assistance Fund.
- 8.3 Approval of Interlocal Agreement for Fire Investigation Services between Mason County and the Mason County Fire Chiefs Association. The cost of this agreement shall not exceed a total of \$158,000 and will be administered through the Department of Community Development.

Cmmr. Sheldon asked for clarification on Item 8.3 for the length of the contract. Cmmr. Neatherlin confirmed the duration of two years.

Questions on Item 8.12 were answered by staff.

Items 8.9 and 8.13 were removed for a separate vote.

**Cmmr. Jeffreys/Sheldon moved and seconded to approve action items 8.1 through 8.14, excluding 8.9 and 8.13. Motion carried unanimously. N-aye; S-aye; J-aye.**

Item 8.9

Approval of letter to the Recreation and Conservation Office (RCO) from the Board of Mason County Commissioners declining acceptance of the Washington Wildlife and Recreation Program (WWRP) grant that would have been utilized to cover 50% of project costs to renovate the infields at MCRA Park - fields #6 and #7. Estimated project cost is \$488,000 and the grant award would have been \$244,000.

John Keates, Facilities, Parks and Trails Director was not available for comment.

Heidi Bailey, Program Support for Facilities and Parks, gave an overview on the grant from Washington Wildlife and Recreation Program (WWRP).

Questions from the audience were answered regarding Item 8.9.

Cmmr. Sheldon explained the use and distribution of the revenues generated from Real Estate Excise Tax (REET) and its purposes per RCW 82.46.035 and implemented under Resolution No. 12-01.

Public Comment

Andrew Kinney, a member of the Mason County Parks and Advisory Board, commented on the RCO grant. He asked the Board consider other opportunities. He added that in-kind services and community effort may help reduce the match requirement for the County and if additional funding can offset the costs. Cmmr. Jeffreys commented on Mr. Kinneys input and bringing solutions to the table.

Kim Goldsby, Head Fast Pitch Coach at Shelton High School, commented on the economic impact of the MRCA playing fields and asked the Board to consider the benefits it would bring to the community to resurface the fields. Cmmr. Jeffreys asked Ms. Goldsby if she would be willing to partner with the school to work with the County to find a solution.

Monty Ritter, a member of the Mason County Parks Advisory Board, expressed concern on the MCRA Park stating that there is an opportunity to alter the needs and asked the Board to wait with their decision to decline the grant. Cmmr. Neatherlin commented that they have discussed options and solutions. Cmmr. Sheldon asked for clarification on the cutoff. Cmmr. Neatherlin clarified on the RCO grant deadline must be completed by December 2014 to be reimbursed.

Don Johnson of Shelton commented on the park systems in the County and stated if money is available that they should take advantage of it.

Shelton High School student Samantha R. commented on the damaged fields at the MCRA Park and the impact the fields have to the students and the community and asked the Board not to deny the RCO grant.

Linda Woytowich, a member of the Mason County Parks Advisory Board, commented on the community support adding that the park is an asset to the community and asked the Board for time to find additional support.

Arvilla Oldhe of Belfair commented on the RCO grant and asked the Board to follow through with their promise and agree to use the grant and certify the match.

Cmmr. Sheldon commented that there is no choice for the board to delay; it is a temporary setback explaining that the RCW spells out where the REET funds can be used.

Cmmr. Jeffreys commented that they should try to reduce the County's portion of the RCO grant match. Cmmr. Sheldon suggested they decline acceptance and table the topic until they receive additional information on the RCO grant requirements and discuss further when John Keates is available.

**Cmmr. Sheldon/Jeffreys moved and seconded to table Item 8.9 in order to learn more about the requirements. Item tabled to January 7, 2014. N-aye; S-aye; J-aye.**

Item 8.13 Approval to adopt the 2014 Property Tax Levies:

Current Expense Levy: Approve resolutions to set the 2014 Current Expense Property Tax Levy at \$9,329,228 which is 1% greater than the previous year.

Road Levy: Approve Resolutions to set the 2014 Road Property Tax Levy at \$9,428,875 which is 1% greater than the previous year.

8:13 Skokomish Flood Control Zone District: Approve resolutions to set the 2014 Skokomish Flood Control Zone District Property Tax Levy at \$0, which is \$0 less than the previous year.

Neatherlin suggested that Skokomish Flood Control Zone District be under Item 8.13; Current Expense Levy referenced under Item 8.15; and Road Levy referenced by Item 8.16. Motion approved. N-aye; S-aye; J-aye.**

Mary Jean Hrbacek respectfully disagreed with Mr. Davis, commenting that the addition of the 1% increase would be enough to add another Deputy.

9. 9:30 a.m. Public Hearings and Items Set for a Certain Time
- 9.1 Public hearing to consider adoption of revised Mason County Comprehensive Plan, Chapter VI (Capital Facilities) in accordance with RCW 36.70A.70. Barbara Adkins presented the current amendments for adoption. She explained the revisions and adjustments made to Capital Improvements.

Staff answered questions from the audience.

Public Testimony:

Tom Davis commented that the Belfair Sewer System needs to be hooked up now.

Pat Loudin commented on the Belfair Sewer System, suggesting that the Urban Growth Area boundaries be changed.

Ken VanBuskirk commented on CF503 of the Capital Facilities Plan. He encouraged the Board to ask both the Planning Advisory Commission and the Department of Community Development to update the UGA boundaries of Comprehensive Plan.

Craig Zetner, Department of Ecology, commented on the Belfair Sewer and extending the sewer into the UGA.

Ken VanBuskirk asked Craig Zetner for clarification on the water quality in the lower Hood Canal. Craig Zetner commented that he could not answer and would need to review data.

Colin Watson asked for clarification on how iron was treated in the Belfair sewer system. Tom Moore, Deputy Director of Public Works and Utilities, commented that they do not treat for iron, but it is monitored in the ground water wells in elevated levels.

Arvilla Oldhe commented on the Belfair Sewer project and asked for clarification on the expenditures and how it is listed in the Comprehensive Plan.

Commissioner's Discussion:

Cmmr. Sheldon commented that he is not inclined to accept the amendment as it is written.

Cmmr. Jeffreys commented on the language of CF503 and how it was written.

**Cmmr. Sheldon/Jeffreys moved and seconded to delete the changes to the policies CF503 to the proposed Comprehensive Facilities Plan. Cmmr. Neatherlin asked to abstain from the vote. Motion passed. N-abstain; S-aye; J-aye**

Cmmr. Neatherlin explained that the original wording of CF503 will be added back in to the Comprehensive Plan.

**Cmmr. Jeffreys/Neatherlin moved and seconded to consider the Capital Facilities Plan be tabled until December 24 for further review and briefing from staff. Motion passed. N-aye; S-aye; J-aye.**

Cmmr. Sheldon commented that he was comfortable adopting the Capital Facilities Plan with the amendments made and did not find it necessary to table any further.

Barbara Adkins was concerned if there would be any impacts on the ability to have a second vote on the same document.

Cmmr. Jeffreys commented that amending a draft that hasn't been officially approved should not cause an issue.

- 9.2 Public hearing to consider amending the Environmental Health Fee schedule effective January 2014.

Debbie Riley presented the amended fee schedule.

**Cmmr. Jeffreys/Sheldon moved and seconded to approve to amend the Environmental Health Fee Schedule effective January 2014. Motion carried. N-aye; S-aye; J-aye. EXHIBIT L**

- 9.3 Public hearing to consider the following changes to the 2013 budget: \$250,000 budget transfer from Current Expense Fund budgeted ending fund balance to Current Expense/Sheriff – Jail Care & Custody Program for inmate medical expenses.

Frank Pinter presented the amended budget for adoption.

Staff answered questions from the audience.

Tom Davis commented if additional costs due to injuries could be avoided with a new security system.

Cmmr. Sheldon commented that the budgeted fund is for a variety of unforeseen circumstances.

Cmmr. Jeffreys read a letter that she drafted to the FFA, to include 4,010 signatures, asking the FAA to allow the fairgrounds to remain at the present location. Cmmr. Jeffreys asked the Board for their approval to sign the letter.

**Cmmr. Jeffreys/Sheldon moved and seconded to sign a letter to the FAA dated December 17, 2013. Motion carried unanimously. N-aye; S-aye; J-aye.**

- 10.3 Trust Land - regarding letters received from Bureau of Indian Affairs

Cmmr. Sheldon commented on the notices received regarding trust land and expressed concern that there are never maps included with the letters. He asked the Board if they would agree to instruct GIS to a parcel map of the areas proposed for trust. Both Cmmr. Jeffreys and Cmmr. Neatherlin agreed.

Cmmr. Jeffreys asked the Board if they would concur with the request that the Board of Indian Affairs to contact adjacent land owners. Both Cmmr. Sheldon and Cmmr. Neatherlin concurred and agreed to investigate additional options.

11. Board's Reports and Calendar - The Commissioners reported on meetings attended the past week and announced their upcoming weekly meetings.
12. Adjournment – The meeting adjourned at 12:45 p.m.



RESOLUTION NO. 69-13

DECLARATION OF SURPLUS PROPERTY AND APPROVAL OF SALE

WHEREAS, Mason County owns the real property listed and legally described in Exhibit A, Attached hereto; and

WHEREAS, certain parcels of the property are tax title property with delinquent property tax, penalties, interest and expenses owing; and

WHEREAS, other parcels were acquired for various purposes; and

WHEREAS, the Board of County Commissioners upon the recommendation of the Property Manager has determined that the property is surplus to the needs of the County; and

WHEREAS, Mason County has received an offer to purchase the property in the amount of \$195,000.00 from Evergreen Rural Water of Washington; and

WHEREAS, the Mason County Board of Commissioners, on May 4<sup>th</sup>, 2010 held a public hearing during which members of the public were able to testify before the Mason County Board of Commissioners regarding the property, the proposed declaration of surplus and sale.


NOW, THEREFORE, BE IT FURTHER RESOLVED by the Mason County Board of County Commissioners that the property described in Exhibit A, attached hereto, is declared surplus property and that sale of said property to Evergreen Rural Water of Washington, at a price of \$195,000.00, is approved; and

BE IT FURTHER RESOLVED, that the proceeds of the sale of said property are to be dedicated first to any delinquent property tax obligations and related penalties, expenses and assessments; and next to reimbursement of the Facilities and Parks fund for expenses of the Property Manager; and finally to the Reserve for Accrued Leave Fund; and


BE IT FURTHER RESOLVED, that the chair of the Commission is authorized to sign the related closing documents and the property manager initiate payment of 7% fee of sale price to the County's real estate agent.



NOTICE IS HEREBY GIVEN that pursuant to the emergency provisions of RCW 36.75.270 and RCW 46.44.080, all Mason County Roads are hereby immediately subject to closure for travel by all vehicles exceeding the weight and/or speed limits as listed herein for a period of one (1) year from this date. (Note: The Board may suspend or extend the closure on any County Road by independent action according to the prevailing conditions.)

THIS ORDER shall supersede for the period designated, any previous order in conflict herewith, provided that this order shall not supersede or modify any restrictions now in force covering load limits on bridges located upon county roads.

IN ACCORDANCE WITH RCW 36.75.270 and RCW 46.44.080, these emergency restrictions may be imposed effective immediately, by posting the roads involved.

WHEN IMPOSING LOAD RESTRICTIONS pursuant to this Resolution, the Mason County Road Department shall specify and display by posted signs, whichever of the above schedules of load restrictions is necessary to protect the County Road from damage.

NO ALLOWANCE SHALL BE MADE for any second gear axle suspended from the frame of the vehicle independent of the regular driving axle, otherwise known as "rigid trail" axles. Allowance will be made for single tires only on the front of any truck. The load distribution on any axle of a vehicle shall be such that it will not load the tires on said axles in excess of the prescribed load, as above set forth. Any loading in excess of the specified maximums as listed herein will be considered a violation of this order. If the motive power for any type of trailer is inadequate to safely handle the specified maximum load as listed herein for such trailer, then in that event, the load on the trailer shall be reduced sufficiently to allow said truck and trailer to operate with safety.

PERMITS ALLOWING TRANSPORTATION ALONG RESTRICTED ROADS. Permits may be issued by the Mason County Road Department to allow the operation of trucks transporting perishable commodities or commodities necessary for the health and welfare of local residents on such county roads, which may be closed or restricted. Such permit may include weight and speed restrictions, plus other restrictions deemed necessary to protect the roadway from undo damage. Vehicles with a gross weight of less than 10,500 lbs (GVW) shall be permitted to operate at full capacity under this resolution. (By general rule emergency vehicles do not need a special permit, but may require weight and speed restrictions. School buses maybe required to run emergency bus routes with possible speed restrictions).

VIOLATION-TRAFFIC INFRACTION. Any violation of these restrictions constitutes an infraction under the provisions of RCW 46.44.105; RCW 46.44.080. Any person found to have violated any posted limitations COUNTY of a highway or section of highway shall be assessed a monetary penalty of not less than one hundred and fifty dollars.



**WHEREAS**, the Mason County Board of health met on November 26, 2013 and reviewed and deliberated on the appropriate fees for public health goods and services , and

**WHEREAS**, the proposed Environmental Health Fees for 2014 were approved by the Mason County Board of Health on November 26, 2013,


