Commissioners Discuss Oakland Bay *Clean Water Initiative* at their May 15 Meeting

The Mason County *Clean Water Initiative* will focus on protecting waterways – and the shorelines, wetlands, and forests that surrounds them. The health and cleanliness of these waters fuels our economy, feeds our families, and lifts our spirits. These waters are at risk. Pollution from stormwater runoff, on-site septic systems, lawn and garden chemicals and other sources threatens to spoil our local waterways.

"It makes sense to focus our resources on monitoring and protecting these waters while they are in pretty good shape, because clean up is difficult and costly", says Commissioner Lynda Ring Erickson.

At their May 15 meeting, Mason County Commissioners will take the first step towards protecting our local waters. They will be consider designating Oakland Bay as an initial focus area for the Mason County *Clean Water Initiative*.
