Spring is here and so are the opportunities for Mason County residents to dispose of their yard debris and recyclable metals at no charge.

From April 1st through the 30th, 2008 the Mason County Department of Utilities and Waste Management will accept yard debris and recyclable metals at the Shelton and Belfair Solid Waste Facilities.

In addition, Mason County has again partnered with local businesses to allow residents to drop off acceptable materials directly at their facilities for no charge.

Participants are advised to please call ahead for information on hours, days of operation, and more information on acceptable materials.

Metals, refrigeration units, appliances and auto hulks will be taken for no charge at the following businesses:

Mason County Salvage, 1840 W. Cloquallum Rd. 360-426-8626. Tuesday through Saturday 8:30 AM to 4:30 PM. Accepting items April 1st through 30th, 2008.

Shelton Auto Parts, 1501 Dayton Airport Rd. 360-427-5150, Monday through Saturday, 9:00 AM to 5:00 PM. Accepting items April 1st through 30th, 2008.

Hwy 3 Auto Wrecking 8633 E Hwy. 3. 360-426-0809. 9:00 AM to 5:00 PM, Monday through Saturday.

Yard and Wood debris can be dropped off April 1st through the 30th, 2008 by appointment only at Bill McTurnal Enterprises, 721 Kamilche Lane, 360-432-0971. There will be a charge to commercial haulers.

Stumps, brush, grasses, leaves, and new building materials will be accepted April 1st through April 13th 2008. Hours Monday thru. Saturday 8 AM to 4:45 PM, and Sunday 10:00 AM to 2:45 PM., at Mason County Wood recyclers, 2994 Johns Prairie Rd. 360-432-9222.

Again, this free opportunity is available to residential customers only; commercial haulers will be charged.
