RESOLUTION NO. 482

ESTABLISHMENT OF MASON COUNTY WEED CONTROL DISTRICT

WHEREAS, the Board of County Commissioners of Mason County, Washington did receive petitions requesting the formation of a weed control district for Mason County; and

WHEREAS, a public hearing on the proposed establishment of such a district was duly noticed and held on April 15, 1974, pursuant to Section 4, Chapter 113, Laws of the 1969 1st Extraordinary Session, and it was found there was a need, due to damaging infestation of noxious weeds, to activate a County-wide Weed Control District; and

WHEREAS, on June 3, 1974, boundaries for the five districts of the Mason County Weed Control District were defined, as set out in the attached descriptions and map;

THEREFORE, BE IT HEREBY RESOLVED that there be created a Mason County Weed Control District, pursuant to the above-mentioned law; that the County be divided into five districts as set out in the aforementioned attachment; and that one voting member from each district be appointed to the Mason County Weed Control Board, who, together with the Mason County Extension Agent, will comprise the membership of the Board.

Commencing at the intersection of the West line of Section 36, Township 21 North, Range 3 West, W.M., and the center line of Oakland Bay, thence Northerly along the West line of Sections 36, 25, 24, 13, 12 and 1, Township 21 North, Range 3 West, W.M., and Section 36, Township 22 North, Range 3 West, W.M., to the intersection of the center line of the Hood Canal, thence Northeasterly along the center line of the Hood Canal to a point which bear North of the Northeast corner of Section 22, Township 22 North, Range 2 West, W.M., thence South to the Northeast corner of Section 22, Township 22 North, Range 2 West, W.M., thence continue Southerly along the East line of Sections 22, 27 and 34 to the Southeast corner of Section 34, Township 22 North, Range 2 West, W.M., thence Easterly along the North line of Sections 2 and 1, Township 21 North, Range 2 West, W.M., and Sections 6, 5 and 4, Township 21 North, Range 1 West, W.M., to the intersection of the centerline of the Case Inlet, thence Southerly along the centerline of the Case Inlet to the intersection of the centerline of Dana Passage, thence Westerly along the centerline of Dana Passage to the intersection of the centerline of Totten Inlet, thence Northerly along the centerline of Totten Inlet to the intersection of the centerline of Hammersley Inlet, thence Westerly along the centerline of Hammersley Inlet to the intersection of the centerline of Oakland Bay, thence along the centerline of Oakland Bay to the intersection of the West line of Section 36, Township 21 North, Range 3 West, W.M., and the point of beginning.

DISTRICT III

Commencing at the Southwest corner of Section 31, Township 21 North, Range 6 West, W.M., and a point of the 5th Standard Parallel, thence Easterly along said 5th Standard Parallel to the Northwest corner of Section 1, Township 20 North, Range 5 West, W.M., thence Southerly along the West line of Section 1, Township 20 North, Range 5 West, W.M., to the Southwest corner of said Section 1, thence Easterly along the Southe line of Section 1, Township 20 North, Range 5 West, W.M., and Sections 6, 5, 4 and 3, Township 20 North, Range 4 West, W.M., to the Southeast corner of Section 3, Township 20 North, Range 4 West, W.M., thence South along the West line of Section 11, Township 20 North, Range 4 West, W.M., to the Southwest corner of said Section 11, thence Easterly along the South line of Sections 11, 12, Township 20 North, Range 4 West, W.M., and Sections 7 and 8, Township 20 North, Range 3 West, W.M., to the Northwest corner of Section 16, Township 20 North, Range 3 West, W.M., thence Southerly along the West line of Section 16, Township 20 North, Range 3 West, W.M., to the intersection of the centerline of Oakland Bay, thence Northeasterly along the centerline of Oakland Bay to the intersection of the East line of Section 35, Township 21 North, Range 3 West, W.M., thence Northerly along the East line of Sections 35, 26, 23, 14, 11 and 2, Township 21 North, Range 3 West, W.M., and Section 35, Township 22 North, Range 3 West, W.M., to the intersection of the centerline of the Hood Canal, thence Westerly along the centerline of Hood Canal to the intersection of a line projected East from the Northwest corner of Section 26, Township 22 North, Range 4 West, W.M., thence West along said projected line to the Northwest corner of Section 26, Township 22 North, Range 4 West, W.M., Westerly along the North line of Sections 27, 28, 29 and 30, Township 22 North, Range 4 West, W.M., and Sections 25, 26, 27 and 28, Township 22 North, Range 5 West, W.M., to the Northwest corner of Section 28, Township 22 North, Range 5 West, W.M., thence continue West to the intersection of the West line of Range 6 West, W.M., thence Southerly along said West line of Range 6 West, W.M., to a point on the 5th Standard Parallel and the point of beginning.

Commencing at the Southwest corner of Section 35, Township 22 North, Range 2 West, W.M., thence Easterly along the South line of Sections 35 and 36, Township 22 North, Range 2 West, W.M. and Sections 31, 32 and 33, Township 22 North, Range 1 West, W.M., to the intersection of the centerline of Case Inlet, thence Northeasterly along the centerline of Case Inlet to the intersection of the East line of Section 33, Township 22 North, Range 1 West, W.M., thence Northerly along the East of Sections 33, 28, 21, 16, 9 and 4, Township 22 North, Range 1 West, W.M., and Sections 33, 28, 21, 16, 9 and 4, Township 23 North, Range 1 West, W.M., to the Northeast corner of Section 4, Township 23 North, Range 1 West, W.M., thence Westerly along the North line of Sections 4, 5; and 6, Township 23 North, Range 1 West, W.M., and Sections 1, 2, 3, 4, 5 and 6, Township 23 North, Range 2 West, W.M., and Section 1 and 2, Township 23 North, Range 3 West, W.M., to the intersection of the centerline of the Hood Canal, thence Southerly and Easterly along the centerline of the Hood Canal to the intersection of a line projected North from the Northwest corner of Section 23, Township 22 North, Range 2 West, W.M., thence South to the Northwest corner of Section 23, Township 22 North, Range 2 West, W.M., thence continue Southerly along West line of Sections 23, 26 and 35, Township 22 North, Range 2 West, W.M., to the Southwest corner of Section 35, Township 22 North, Range 2 West, W.M., and the point of beginning.

DISTRICT V

All that portion of Mason County lying West of the centerline of the Hood Canal and North of a line projected along the Southerly line of Sections 24, 23, 22, 21, 20 and 19, Township 22 North, Range 4 West, W.M., and 24, 23 and 22, Township 22 North, Range 5 West, W.M., and continuing from the Southwest corner of Section 22, Township 22 North, Range 5 West, W.M., West to the West line of Range 6 West, W.M., the terminus of said projected line.
