RESOLUTION OF INTENT TO GRANT FRANCHISE AND NOTICE OF HEARING

WHEREAS, Mason County Board of Commissioners intend to grant a franchise for the purpose of providing cable television service to specific areas of Mason County; and

WHEREAS, the Commissioners have received an application to provide cable television service by Olympic TV Cable, PO Box 88, Port Orchard, Washington 98366; and

WHEREAS, Olympic TV Cable has proposed to provide cable television service to the following areas of Mason County served by county roads:


WHEREAS, the franchise for cable television service sets forth provisions for a minimum number of viewing channels, plus additional terms and conditions; and


WHEREAS, the Resolution Granting a Franchise is available in the Office of the County Auditor for review;




