

OPINANCE NO. 50-81
AMENDMENTS TO MASO COUNTY SANITARY CODE, ARTICLE VI

WHEREAS, the Board of Health for Mason County on December 18, 1978, adopted the rules and regulations of the Thurston-Mason Health District effective January 1, 1979 according to RCW 70.05.060 (3); and

WHEREAS, the Board of Health desires to simplify the sewage permit procedure; and

WHEREAS, the Board of Health held a Public Hearing on April 21, 1981, for the purpose of reviewing the proposed amendments, deletions and additions to the Mason County Sanitary Code Article VI;

NOW, THEREFORE, BE IT RESOLVED, that the following amendments, deletions and additions to Mason County Sanitary Code, Article VIII, be adopted:

Delete Section 1.6

Delete Section 3

Add a new Section 3

SECTION 3: Sewage System Permits

3.1 No person shall install a new sewage system, excluding public sewage works, nor perform alterations, extensions or relocations of an existing system without a valid sewage system permit issued by the health officer. Permits for alterations or repairs shall be so identified. Application for such permit shall be made in writing in a manner prescribed by the health officer.

3.2 When applying for a permit to install an on-site sewage disposal system, a construction plan of the proposed system is required. The construction plan shall contain information as required by the health officer in sufficient detail and to a scale which will permit a proper evaluation of the application. Such information should contain the following as a minimum:

- (a) Name of applicant and legal description of site.
- (b) Soil logs describing nature and depth of soils.
- (c) Percolation test data where required.
- (d) Anticipated maximum seasonal ground water table.
- (e) General topography of the site and site drainage characteristics.
- (f) Distances of proposed system to water supplies, surface water, banks or cuts, boundaries of property and structures or other improvements.
- (g) Distance to public sewer system

3.3 A sewage system permit shall be valid for three years from date of approval.

3.4 A sewage system permit shall be approved by the Health Officer when the plans and specifications proposed on the application conform with the provisions of this Article VI and Article VII.

Delete Section 4

Add a new Section 4

Section 4: Site Inspection Applications and Sewage Permits Submitted Prior to July 1, 1981.

4.1 Site Approvals submitted prior to July 1, 1981, shall expire 4 years from date of site approval.

4.2 The sewage permits for all unapproved site inspection applications submitted prior to July 1, 1981, shall be obtained at the time of the approval of the site inspection. The sewage permit for all approved site inspection applications approved prior to July 1, 1981 shall be obtained before the system is installed.

4.3 A "Permit shall expire and be Void" four years from date of issuance of site approval.

This Article shall be amended and shall be in full force and effective on July 1, 1981.
