A G R E E M E N T

MASON COUNTY & SHELTON-MASON COUNTY CHAMBER OF COMMERCE

THIS AGREEMENT between MASON COUNTY, hereinafter referred to as "COUNTY", and the Shelton-Mason County Chamber of Commerce, a non-profit organization, hereinafter referred to as the "CHAMBER".

WITNESSETH:

That in consideration of the terms and conditions contained herein, the parties hereto covenant and agree as follows:

- 1. The CHAMBER agrees to provide services to COUNTY as follows:
 - 1.1 Market the tourism potential of the COUNTY via advertising, promotional presentations, personal contact and mailings.
 - 1.2 Encourage the establishment of environmentally and financially sound tourism attractions in the COUNTY.
 - $1.3\,$ Seek alternatives for financing the efforts of the CHAMBER.
 - 1.4 Inform individuals and businesses of the various tourism services, programs and resources available to them in Mason County.
- 2. The CHAMBER will submit through the Auditor and to the County Commissioners monthly reports specifying the exact amount of COUNTY monies expended for each authorized activity; and supported where possible, by attached bills, receipts or other similar documentation.
- 3. The CHAMBER will hold the COUNTY harmless from all claims of every kind and character arising out of or in any way connected with the services given by it for the COUNTY.
- 4. It is understood that the CHAMBER is an independent contractor and is not an agent of the COUNTY, and all personnel used by the CHAMBER in connection with the rendering of services contemplated by this contract shall be employees of the CHAMBER and

not the COUNTY, and shall have no claim against the COUNTY for compensation or other benefits available to the employees of said COUNTY.

- 5. This agreement shall be for a term of one (1) year, beginning January 1, 1985, and renewable for additional one-year terms by mutual written consent of the parties.
- 6. The COUNTY will pay the CHAMBER for the services to be performed under this contract of the 1985 calendar year, a sum not to exceed \$3,000.00 to be paid monthly on vouchers to be presented by the CHAMBER to the COUNTY at the close of each month with the monthly report. Funds paid for such services will be used to furnish only the services contemplated by this contract and will not be diverted by the CHAMBER to any other person or used for any other purpose. CHAMBER records of receipt and expenditure of such funds will be made available on request to COUNTY official and the State Auditor for review.
