A JOINT RESOLUTION of the Thurston, Grays Harbor, Mason and Kitsap Counties Board of County Commissioners appointing a member to represent the 35th Legislative District in the Washington State Senate.

WHEREAS, a Vacancy has been created in the 35th Legislative District in the Washington State Senate; and

WHEREAS, the 35th Legislative District is a joint Legislative District located partly in Thurston, Grays Harbor, Mason and Kitsap Counties, and the Washington State Constitution, Article II, Section 15, provides in such cases that the vacancy be filled by joint action of the legislative bodies of the four counties; and


Section 1: Lena Swanson is one of the three nominees submitted by the Washington State Democratic Central Committee, and is qualified to fill the Senate vacancy.
