

RESOLUTION NO. 147-97

WHEREAS, on September 16, 1997, the Board of Mason County Commissioners adopted Ordinance No. 107-97, amending Mason County Addressing Ordinance No. 1091; and

WHEREAS, Ordinance No. 107-97 amended Section 3.04, Structure Addressing, to read: ".....Mile Point Number, District Indicator, and Road Name.....," which resulted in changing all addresses within Mason County by placing the directional after the address number; and

WHEREAS, to facilitate this address change requirement, it is necessary to change the names of existing roads that have the directional at the beginning, and

WHEREAS, a public hearing was held December 16, 1997, to afford the public an opportunity to provide input regarding those road names which are to be changed; and,

WHEREAS, it appears to be in the best interest of the citizens of Mason County to change the names of the following Mason County roads:
