SUPPLEMENTAL APPROPRIATION NOTICE OF HEARING

That the 18th day of August, 1998 at the hour of 9:15 a.m. in the Mason County Commission Chambers, at Courthouse Building 1, 411 North Fifth Street, Shelton, Washington, is hereby fixed as the time and place for a public hearing upon the matter of a supplemental appropriation to the budget for the Landfill Fund in the estimated amount of \$30,000.
