

RESOLUTION NO. 90-01

AGREEMENT

This agreement between Mason County, hereinafter referred to as "COUNTY," and The ALLYN COMMUNITY ASSOCIATION, a nonprofit organization, hereinafter referred to as the "ALLYN COMMUNITY ASSOC.."

WITNESSETH:

That in consideration of the terms and conditions contained herein, the parties hereto covenant and agree as follows:

I. The ALLYN COMMUNITY ASSOC. agrees to provide the "North Bay Kayak Festival" event as approved by the Mason County Tourism Task Force. The Mason County Tourism Task Force has determined this event meets the criteria as outlined in RCW 67.28.080:

"... advertising, publicizing, or otherwise distributing information for the purpose of attracting and welcoming tourists..."

II. The ALLYN COMMUNITY ASSOC. will submit to the COUNTY documentation (invoices, etc.) verifying the money was spent for the North Bay Kayak Festival.

III. The ALLYN COMMUNITY ASSOC. will hold the COUNTY harmless from all claims of every kind and character arising out of or in any way connected with the services given by it for the COUNTY.

IV. It is understood that the ALLYN COMMUNITY ASSOC. is an independent contractor and is not an agent of the COUNTY, and all personnel used by the ALLYN COMMUNITY ASSOC. in connection with the rendering of services contemplated by this contract shall be employees of the ALLYN COMMUNITY ASSOC. and not the COUNTY, and shall have no claim against the COUNTY for compensation or other benefits available to the employees of said COUNTY.

V. This agreement shall be for a term of five months beginning August 1, 2001.

VI. The COUNTY will remit \$1,000 in Hotel/Motel funds to the ALLYN COMMUNITY ASSOC. for the services to be performed under this contract. Funds paid for such services will be used to furnish only the services contemplated by this contract and will not be diverted by the ALLYN COMMUNITY ASSOC. to any other person or used for any other purpose. ALLYN COMMUNITY ASSOC. records of receipt and expenditure of such funds will be made available on request by County officials and the State Auditor for review.
