

RESOLUTION NO. 153-02

A RESOLUTION confirming and approving the roll of rates and charges for Mason County Lake Management District No. 2 for Mason Lake pursuant to RCW 36.61.120.

WHEREAS, Mason County Lake Management District No. 2 ("LMD No. 2") for Mason Lake, was established on October 22, 2002 by adoption of Ordinance No. 141-02; and

WHEREAS, the notice and hearing requirements for establishing the roll of rates and charges, enters the following findings of fact:

1. LMD No. 2 Activities: The LMD No. 2 proposes to perform the following activities:
 - Manage noxious aquatic plants in Mason Lake to meet recreational and aesthetic needs, fishery and wildlife habitat requirement and ecosystem and groundwater concerns.
 - Employ proven techniques based on environmental safety.
 - Conduct water quality monitoring as needed
 - Investigate and promote the best management practices and shoreline enhancement
 - Monitor for recurrence of milfoil or emergency of other lake plants that could adversely impact the freshwater system and recommend prompt action to control these.
 - Maintain an advisory committee of neighborhood representatives to direct the efforts and funds of the LMD No. 2.
2. LMD No. 2 will protect Mason Lake's beneficial uses and water quality and is in the public interest.
3. The duration of the LMD No. 2 shall be five 5 (five) years, commencing in 2003.
4. The proposed Management Plan for Mason Lake takes appropriate measures to protect and enhance fish and wildlife.
5. The proposed financing of Lake Management activities is feasible and the level of funding is sufficient to conduct the contemplated activities.
6. The proposed annual rates and charges set forth on the attached roll bear a reasonable relationship to the benefit to property within LMD No. 2 for protecting the lake's water quality, recreational and aesthetic values.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners for Mason County that the roll of rates and charges for Mason County Lake Management District No. 2 for Mason Lake be confirmed and approved as follows:

1. In light of the analysis contained in the Findings of this Resolution and Resolution No. 97-02, the cost of lake management activities and maximum total annual charges to property as stipulated in Ordinance No. 141-02 and Resolution No. 97-02, the Board establishes the total amount to be collected over five years is \$66,309.

Proposed annual rates and charges to property within Lake Management District No. 2 are as follows:

- \$12,000 annually, commencing in 2003 and continuing through 2007.
2. Method of collection (from Ordinance No. 141-02);
 - A. Rates and charges for LMD No. 2 shall be included in Mason County's annual property tax statements. Properties, which do not receive a property tax statement, will receive separate billing statements for these rates and charges.
 - B. The total amount of the LMD No. 2 annual rate and charge shall be due and payable on or before the 30th day of April of each year, commencing April 30, 2003, and shall be delinquent after that date; however, if one-half of such rate and charge is paid on or before the said 30th of April, the remainder shall be due and payable on or before the 31st day of October and shall be delinquent after that date.
 - C. If a payment is received in conjunction with a combined property tax and LMD No. 2 rate and charge and the payment is less than the amount due, the payment shall be applied first to the annual property tax of the parcel and any remaining amount to the LMD No. 2 rate and charge.
 3. The roll of rates and charges for Mason County LMD No. 2 for Mason Lake, attached hereto and incorporated by reference, is hereby approved and confirmed.
 4. The funds collected from LMD No. 2 will be rolled into Fund No. 194-100-000 of the Mason County Treasurer's office.
