RESOLUTION NO. 105-07 TO AMEND RESOLUTION NO. 128-06 SOLID WASTE FACILITY & DROP BOX STATION RATES

WHEREAS, RCW 36.32.120 states ". the board of county commissioners... have the care of the county property and the management of the county funds and business."

WHEREAS, the Mason County Landfill Fund (No. 402-000-000) is an enterprise fund, and generally accepted accounting principles require that fees for goods and services in an enterprise fund be adequate to cover the costs of the operations of the enterprise.

WHEREAS, a public hearing was held on December 19, 2006 and amended rates were adopted for 2007.

NOW THEREFORE, IT IS ESTABLISHED THAT Mason County Solid Waste Facility & Drop Box Station Fees are amended for 2008 as shown in Attachment A, effective January 1, 2008.

IT IS FURTHER ESTABLISHED THAT Mason County Solid Waste Facility & Drop Box Station Fees will be increased each year thereafter by the amount of the July to July Consumer Price Index (CPI U) for the Olympia Metropolitan Area.
