TOGETHER with the alley, lying between Block 12 and Block 13 of said Plat of "Town of Allyn".

EXCEPTING therefrom that portion thereof, if any, which includes tidelands.

WHEREAS, the Board did set a date for public hearing on the matter before the Hearings Examiner and directed the Clerk to prepare notice thereof for posting and publication;
