WHEREAS, by reason of conditions which could not be reasonably foreseen at the time of making the budget for the year 2007, it is necessary to make provisions for supplemental appropriations and budget transfers to the 2007 Budget as authorized by RCW 36.40.100 and RCW 36.40.195 for the following:

Supplemental Appropriations to the Department of Emergency Management in the Current Expense Fund for unanticipated revenue from Federal Grants for equipment and other operating expenses.

A Supplemental Appropriation to the Department of Community Development in the Current Expense Fund for unanticipated revenue from the WA State Department of Ecology for professional services.

Budget Transfers from the Ending Fund Balance in the Current Expense Fund to LEOFF for additional medical insurance premiums for retired LEOFF I employees, to Budget & Finance/Risk Management for the additional costs of employee training, to Juvenile Detention for additional costs of 2007 wage & benefit settlements (shift differential) and to the Fairgrounds for additional costs of 2007 medical/dental benefits.

Supplemental Appropriation: Emergency Management/Current Expense Fund in the estimated amount of \$143,372, Department of Community Development/Current Expense Fund in the estimated amount of \$13,050.

Budget Transfers: Current Expense Fund from Ending Fund Balance to LE0FF \$8,178, to Budget & Finance/Risk Management \$10,990; to Juvenile Detention \$2,630, and to Fairgrounds \$540. (Total Budget Transfers \$22,338)
